RATIFICATION OF AMENDMENT TO EXTENSION OF EMERGENCY ORDER NO. 20-09

CONTINUED GUIDELINES CONCERNING NUMBERS OF ATTENDEES, SOCIAL DISTANCING, AND USE OF FACE COVERINGS AT PARTIES AND OTHER GATHERINGS

WHEREAS, the City of Urbana ("City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any function pertaining to its government and affairs, including the power to regulate for the protection of the public health, safety, and welfare; and

WHEREAS, on March 16, 2020, the City Council adopted Ordinance No. 2020-03-015, Temporary Emergency Ordinance to Address the COVID-19 Pandemic; and

WHEREAS, Section 13 of Ordinance No. 2020-03-015 provides that all emergency orders

issued by the Mayor shall be subject to review and ratification by the City Council; and

WHEREAS, on April 16, 2020, the City Council adopted Ordinance No. 2020-04-024 – Reaffirmation of Ordinance No. 2020-03-015 and Reissuance of Mayor's Authority to Issue Temporary Declaration of Emergency; and

WHEREAS, on August 24, 2020 and pursuant to Ordinance No. 2020-03-015 and Ordinance No. 2020-04-024, the Mayor issued Emergency Order 20-09 – Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings; and

WHEREAS, on September 21, 2020 and pursuant to Ordinance No. 2020-03-015 and Ordinance No. 2020-04-024, the Mayor issued the Extension of Emergency Order 20-09 – Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings; and

WHEREAS, the City Council has reviewed the Amendment to the Extension of Emergency Order No. 20-09 – Continued Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings a copy of which is appended hereto.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

The City Council, after reviewing the Amendment to the Extension of Emergency Order No. 20-09 – Continued Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings, hereby ratifies and confirms the said Amendment to the Extension of Emergency Order No. 20-09 – Continued Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings a copy of which is appended hereto and the same shall remain in full force and effect as provided in Section 2 thereof. Notwithstanding, the immediate foregoing, the City Council shall have the authority to repeal this Ordinance prior to any of the termination actions provided in said Section 1 of the said Amendment to the Extension of Emergency Order No. 20-09 – Continued Guidelines Concerning Numbers of Attendees, Social Distancing, and Use of Face Coverings at Parties and Other Gatherings.

Section 2.

This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Amendment to EXTENSION OF EMERGENCY ORDER NO. 20-09

CONTINUED GUIDELINES CONCERNING NUMBERS OF ATTENDEES, SOCIAL DISTANCING, AND USE OF FACE COVERINGS AT PARTIES AND OTHER GATHERINGS

Effective Date: October 30, 2020 at 11:59:59 p.m.

The Mayor, pursuant to Ordinance No. 2020-03-015 – Temporary Emergency Order to Address the COVID-19 Virus Pandemic, Section 13; Ordinance No. 2020-04-024 – Reaffirmation of Ordinance No. 2020-03-015 and Reissuance of Mayor's Authority to Issue Temporary Declaration of Emergency; Governor Pritzker's Restore Illinois Plan - Phase 4 Guidelines, the Illinois Department of Public Health Emergency Rules to Enforce the Use of Face Coverings (77 Ill. Adm. Code 690.50 *et seq.*); and the Champaign-Urbana Public Health District Ordinance No. 2020-08-05 that has incorporated the Illinois Department of Public Health's Emergency Rules to Enforce Use of Face Coverings with certain limited exceptions hereby orders as follows:

That Extension of Emergency Order 20-09 is hereby amended as follows:

(1) That Section 4 entitled "Duration of Emergency Order 20-09" is hereby amended to read as follows:

Duration of Emergency Order 20-09. This extended Order shall continue in effect from its effective date unless earlier terminated by the City Council or extended by the Mayor with ratification by the City Council.

(2) All other parts of Extension of Emergency Order 20-09 not changed by this amendment shall remain in full force and effect.
