**AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES
FOR THE TOWN OF CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS,
FOR THE TAX YEAR 2014, COLLECTIBLE IN 2015**

An ordinance levying taxes for all town purposes for the Town of Cunningham, Champaign County, Illinois, for the tax year 2014, collectible in 2015.

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other statutes as are applicable, the sum one million, three hundred three thousand, three hundred fifty-eight dollars and zero cents (\$1,303,358.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Assistance Fund	\$ 542,866.00

for the tax year 2014, collectible in 2015.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Champaign, on or before Wednesday, December 31, 2014, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
