# URBANA CITY COUNCIL MEETING MONDAY, April 6, 1992 [Recessed to April 7, 1992]

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, April 6, 1992 in the Council Chambers of the Urbana City Building.

Present at the meeting were Members of the Council: Barr, Clark, Pollock, Singer, Smyth, Tarr and Whelan - 7.

There being a quorum, the meeting was called to order at 7:40 p.m. by Mayor Jeffrey T. Markland.

# MINUTES OF PREVIOUS MEETINGS

Alderwoman Barr moved to approve the minutes of the March 2, 1992 regular meeting and the March 23, 1992 special meeting. The motion was seconded by Alderman Pollock and carried by a voice vote.

#### ADDITIONS TO THE AGENDA

In light of the many citizens present to address An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana, Alderman Clark moved to reevaluate the agenda at 10:00 p.m. if petitions and communications extend to that time. The motion was seconded by Alderman Whelan.

Following debate the motion carried by a voice vote.

Alderman Smyth moved to suspend the rules and remove item "b." An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana, under Reports of Standing Committees, Committee on Environment and Public Safety. The motion was seconded by Alderman Pollock.

Following debate, the motion carried voice vote, with Alderman Singer voting nay.

Alderman Singer moved to consider item "e." An Ordinance Revising The Annual Budget Ordinance (Police Mobile Radios), and item "3" under New Business, An Ordinance Approving And Authorizing The Execution Of An Annexation Agreement (Schluter) (Plan Case No. 1467-A-92: Schluter Annexation Agreement) following item "a." ISWDA/Line of Credit Resolution under Reports of Standing Committeess, Committee on Environment and Public Safety, and to add, in conjunction with ISWDA/Line of Credit Resolution, possible closed session to consider possible litigation. The motion was seconded by Alderman Pollock and carried by the requisite two-thirds vote.

# PETITIONS AND COMMUNICATIONS

Alderman Pollock stated that he had supported the motion to remove An Ordinance

Regulating The Possession Of Assault Weapons In The City Of Urbana, based primarily upon the recommendations of legal staff and the fact that the union which represents the City's police officers has expressed its opposition to this Ordinance. He stated that he, along with many Council Members, had a strong concern regarding public safety issues so he would be placing "Public Safety Concerns" on the April 13, 1992 agenda of the Committee on Administration and Finance.

Alderman Whelan addressed the Council, voicing his opposition to An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana.

Alderman Clark expressed his opposition to An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana.

Alderman Smyth voiced his opposition to An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana, as written.

Alderwoman Barr stated that the proposed Ordinance on assault weapons was poorly drafted, but expressed her ongoing support for weapons control in the City.

Alderwoman Tarr stated that she also felt An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana, as written, was flawed, but expressed her concern for weapons control.

Alderman Singer stated that he concurred with the opinion that An Ordinance Regulating
The Possession Of Assault Weapons In The City Of Urbana, as written, presented enforcement problems, but
expressed his opinion that amendments which would "grandfather" existing weapons and delay the effective
date of the Ordinance would address those problems.

Mayor Markland addressed those present, stating that he is opposed to legislation such as An Ordinance Regulating The Possession Of Assault Weapons In The City Of Urbana.

Accordingly, Alderman Pollock moved to table this Ordinance indefinitely pending staff's recommendation. The motion was seconded by Alderman Clark and carried by a voice vote.

# Committee on Environment and Public Safety

The Council went into closed meeting at 10:40 p.m. and reconvened in open session at 11:00 p.m. with all Members previously in attendance still present.

Alderman Singer moved to suspend the rules and consider item "e." under Reports of Standing Committees, Committee on Environment and Public Safety, An Ordinance Revising The Annual Budget Ordinance (Police Mobile Radios), item 2 under New Business, Staff Appointment - Building Inspector II, and item 3 under New Business, An Ordinance Approving And Authorizing The Execution Of An Annexation Agreement (Schluter) (Plan Case No. 1467-A-92: Schluter Annexation Agreement). The motion was seconded by Alderman Whelan and carried by voice vote.

Alderman Singer moved to adopt An Ordinance Revising The Annual Budget Ordinance

(Police Mobile Radios - \$23,100), seconded by Alderman Whelan.

Following debate the motion carried 8-0 by roll call vote. Voting aye were Members of the Council: Barr, Clark, Pollock, Singer, Smyth, Tarr, Whelan and Mayor Markland - 8; voting nay: none.

Alderman Singer moved to approve the staff appointment of Steve Cochran to the position of Building Inspector II. The motion was seconded by Alderman Pollock and carried by a voice vote.

Alderman Singer moved to adopt An Ordinance Approving And Authorizing The Execution Of An Annexation Agreement (Schluter) (Plan Case No. 1467-A-92: Schluter Annexation Agreement), as amended with the new page two which corrects technical errors. The motion was seconded by Alderman Pollock and carried 8-0 by roll call vote. Voting aye were Members of the Council: Barr, Clark, Pollock Singer, Smyth, Tarr, Whelan and Mayor Markland - 8; voting nay: none.

Alderman Singer moved to go into closed session to consider imminent and probable litigation. The motion was seconded by Alderwoman Tarr and carried 7-0 by roll call vote. Voting aye were Members of the Council: Barr, Clark, Pollock, Singer, Smyth, Tarr and Whelan - 7; voting nay: none.

The Council entered into closed session at 11:10 p.m. and reconvened at 12:10 a.m., Tuesday, April 7, 1992, with all Members previously in attendance still present.

Alderman Smyth moved to suspend the rules and adopt An Ordinance Revising The Annual Budget Ordinance (Frasca Consultant - \$24,000). The motion was seconded by Alderman Singer and carried 8-0 by roll call vote. Voting aye were Members of the Council: Barr, Clark, Pollock, Singer, Smyth, Tarr, Whelan and Mayor Markland - 8; voting nay: none.

Alderman Smyth moved to recess the Council meeting to 6:30 p.m., Tuesday, April 7, 1992. The motion was seconded by Alderman Clark and carried by a voice vote. [Corrected to include: "The meeting recessed at 12:15 a.m., Tuesday, April 7, 1992."]

The Council reconvened in open session at 7:02 p.m. with all Members previously in attendance, plus Alderman Smyth, still present.

Alderman Singer moved to approve "A Motion In Support Of The Mayor":

The Urbana City Council unanimously supports the position its Mayor has taken on the question of dissolution of the ISWDA. We suggest that an appropriate course of action before any Member Government considers, even in principle, the dissolution of the ISWDA would be for the Member Government proposing dissolution to present duly enacted Ordinances authorizing the execution of a proposed dissolution agreement and appropriating escrows for all relevant expenditures.

The motion was seconded by Alderwoman Tarr. Alderman Pollock requested a roll call vote. A Motion In Support Of The Mayor carried 5-0 by roll call vote. Voting aye were Members of the Council: Barr, Pollock, Singer, Smyth and Tarr - 5; voting nay: none.

# **ADJOURNMENT**

Alderman Pollock moved to adjourn. The motion was seconded by Alderman Smyth and carried by a voice vote. The meeting was adjourned at 7:07 p.m.
