# URBANA CITY COUNCIL MEETING October 18, 1993

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, October 20, 1993 in the Council Chambers of the Urbana City Building.

Present at the meeting were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor and Whelan - 6.

There being a quorum, the meeting was called to order at 7:30 p.m. by Mayor Tod Satterthwaite.

## MINUTES OF PREVIOUS MEETING

Alderman Hayes moved to approve the minutes of the October 4, 1993 regular meeting. The motion was seconded by Alderman Singer and carried by a voice vote.

#### ADDITIONS TO THE AGENDA

Alderman Singer moved to add "A Resolution Concerning Open Government" to the agenda following A Resolution Regarding Unfunded Mandates . The motion was seconded by Alderwoman Ryan and carried 5-1 by a show of hands vote.

Alderman Singer addressed the Council with preliminary comments regarding solid waste.

# REPORTS OF STANDING COMMITTEES

#### Committee on Administration and Finance

Alderman Pollock moved to adopt by omnibus vote the Annual Tax Levy Ordinance Of The City Of Urbana, Illinois For the Year Beginning July 1, 1993 And Ending June 30, 1994; An Ordinance Abating Tax Levy For \$1.0 Million General Obligation Bonds, Series 1992; An Ordinance Abating Tax Levy For \$2.820 Million General Obligation Bonds, Series 1985; and An Ordinance Abating Tax Levy For

\$3,890,000 Corporate Purpose Bonds. The motion was seconded by Alderman Taylor.

Alderman Pollock moved to defer. The motion was seconded by Alderman Taylor. The ordinances were deferred.

Alderman Pollock moved to adopt An Ordinance Revising The Annual Budget Ordinance (Police and Fire Pension Funds/IMRF). The motion was seconded by Alderman Taylor and carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor, Whelan and Mayor Satterthwaite - 7; voting nay: none.

Alderman Pollock moved to adopt An Ordinance Further Amending No. 8485-38 Entitled, "An Ordinance Designating An Area As An Enterprise Zone" (Peter B's Automotive - 509 North Lierman Avenue). The motion was seconded by Alderman Whelan and carried 6-0 by roll call vote. Voting aye were Members of the Council: Hayes, Pollock, Ryan, Singer, Taylor and Whelan - 6; voting nay: none.

Alderman Pollock reported that the next regular meeting of the Committee on Administration and Finance will be November 8, 1993 at 7:30 p.m.

Committee on Environment and Public Safety

Alderman Singer reported that the next regular meeting of the Committee on Environment and Public Safety will be October 25, 1993.
