# REPORTS OF STANDING COMMITTEES

## Committee on Administration and Finance

Alderman Pollock stated that the next scheduled meeting of the Committee on Administration and Finance will be Monday, March 14, 1994 at

Following further debate, Alderman Whelan moved to send An Ordinance Approving The Solid Waste Management Interim Plan to the Committee on Administration and Finance on March 14, for further review. The motion was seconded by Alderman Taylor.

Following debate, the motion to send An Ordinance Approving The Solid Waste Management Interim Plan to the Committee on Administration and Finance failed 1-6 by roll call vote. Voting aye were Members of the Council: Whelan -

Following debate, Mayor Pro Tem Pollock took the Chair and Mayor Satterthwaite entered debate.

Following further debate, the motion failed 2-5 by roll call vote. Voting aye were Members of the Council: Hayes and Singer - 2; voting nay: Patt,
