Mr. Pollock requested a Point of Order, stating that he did

not believe that the direction Chairman Singer was headed was to discuss the motion and asked that Chairman Singer go on with the motion.

Chairman Singer ruled that Mr. Pollock's statement was not a Point of Order and continued by stating that he was speaking against the motion and would do so at the length he felt necessary to get all the points across.

Chairman Singer continued his debate of the motion.

Ms. Patt called for a Point of Order stating that she did not believe that the twenty minute speech that the Chair just made had any relevance to the motion on the floor and asked that Chairman Singer yield the floor.

Chairman Singer stated that under the Committee rules when a motion is on the floor, and an additional motion is on the floor, it is appropriate to ask whether the additional motion is germane to the original motion. Once the motion is properly on the floor, then the question of debate is not covered in the rules. That is because what a person would like to say about an issue is freedom of speech which is protected under the Constitution.

Ms. Patt moved to challenge the ruling of the Chair. The motion was seconded by Ms. Ryan.

Chairman Singer stated that the motion was not in order.

Mr. Taylor requested that the Committee get advice from its Parliamentarian.

Chairman Singer stated that the Chair is allowed to get advice from the Parliamentarian and does not chose to do so.

Mr. Taylor requested a Personal Indulgence to ask City Attorney Jack Waaler what the procedure is at this point.

Chairman Singer agreed.

Mr. Waaler stated that he was not aware of any circumstances where an appeal for ruling of the Chair would be out of order.

Chairman Singer stated that the Parliamentarian had given his advice, which is advice, not a ruling.

Mr. Taylor requested a brief recess. Chairman Singer
