Before moving on to the adjournment of the meeting, the City Clerk (Phyllis Clark) informed the Council of a request by the Illinois Department of Transportation (IDOT) to change the title of Resolution No. 9798-R20 (Resolution For Improvement By Municipality Under The Illinois Highway Code (Guardian Drive, Butzow Drive)) adopted by the City Council at its February 2, 1998 meeting. IDOT wishes this title corrected to read: "A Resolution Providing For The Construction Of Road Improvements At Guardian Drive And Butzow Drive And At The Intersection Urbana City Council Meeting Monday, February 16, 1998 Page 4

Of Illinois Route 130 And U.S. Route 150."

Alderman Taylor made a motion to accept the title change. Alderwoman Wyman seconded. The motion carried by voice vote.
