Additions to the Agenda and Staff Report

Mayor Satterthwaite announced that the Housing Authority of Champaign County will be making a two-part presentation to Council about the HOPE VI Grant application they are planning to make for redevelopment of Lakeside Terrace. April 6, 1998, at 6:00 p.m. there will be a tour of Lakeside Terrace and discussion with residents. At the April 13, 1998 meeting of the Committee of the Whole there will be a presentation of the HOPE VI proposal by the HACC.

Public Works Director Bill Gray stated that he had an informational memo in the Committee packet regarding suggestions for the Stone Creek subdivision multi-use path accessibility.

Bill Gray stated that a memo had been included in the

packet to provide committee members with a status update on the Boneyard Creek Improvement Plan.

Minutes of Previous Meeting

Ms. Patt moved to approve the minutes of the March 9, 1998 meeting of the Committee of the Whole. The motion was seconded by Mr. Whelan and carried by a voice vote.

An Ordinance Changing A Street Name (Cunningham Avenue)

Bill Gray presented staff report on <u>An Ordinance</u> Changing A Street Name (Cunningham Avenue), stating that Gill Sports has requested to change the name of that part of Cunningham Avenue between Broadway Avenue and Courtesy Road to Courtesy Road. Their customers have trouble locating their facility because Courtesy Road is closed between Vine Street and the Cunningham Bridge over the Boneyard Creek. This section of Cunningham Avenue does not align with the remainder of Cunningham Avenue. As there would be no significant impact caused by this request, staff recommends approval of this ordinance.

Following debate, Mrs. Kearns moved to send <u>An</u>
<u>Ordinance Changing A Street Name (Cunningham Avenue)</u> to Council for approval. The motion was seconded by Ms. Wyman and carried by a voice vote.

A Resolution Amending Housing Rehabilitation Guidelines As Originally Authorized By Resolution No. 7576-26

Grants Management Manager Bruce Stoffel presented staff report on A Resolution Amending Housing Rehabilitation Guidelines As Originally Authorized By Resolution No. 7576-26, stating that this is adoption of a new housing rehabilitation program manual that describes eligibility guidelines and processing procedures for the City's housing rehabilitation programs funded through the Community Development Block Grant program. The new program manual would replace the current guidelines which expire June 30, 1998. The new guidelines would be effective until June 30, 2000. Mark Repogle was present to answer Committee questions regarding housing rehabilitation assistance.

Following debate, Ms. Wyman moved to send <u>A Resolution</u> <u>Amending Housing Rehabilitation Guidelines As Originally</u> <u>Authorized By Resolution No. 7576-26</u> to Council for approval. The motion was seconded by Ms. Patt and carried by a voice vote.
