The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, August 17, 1998, in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Pro Tem Hayes called the meeting to order at 7:35 p.m.

### MINUTES OF PREVIOUS MEETING

Alderman Whelan moved to approve the minutes of the August 3, 1998 regular meeting.

The motion was seconded by Alderwoman Kearns. Alderwoman Wyman requested to change

There were no objections.

### **NEW BUSINESS**

Planner Kim Gerstein presented staff report on Ordinance No. 9899-16: An Ordinance

Extending The Validity Of A Final Plat (Harvest Glen Subdivision - Case No. 1678-S-97) stating that

Harvest Glen Subdivision was approved by the City Council on December 15, 1997. The approved plat

was required to be recorded by April 5, 1998. Due to unforeseen problems, the petitioners were unable to

complete necessary improvements or post a bond required by deadline. The Council granted a 90 day extension to July 3, 1998.

Since that date the petitioners have again experienced problems and are requesting that Council grant a minimum one hundred eighty (180) day extension of the time allotted to record the subdivision plat to Wednesday, December 30, 1998.

Following debate, Alderman Whelan moved to approve Ordinance No. 9899-16: An Ordinance Extending The Validity Of A Final Plat (Harvest Glen Subdivision - Case No. 1678-S-97).

The motion was seconded by Alderwoman Patt and carried 5-1 by roll call vote. Voting aye were Members of the Council: Hayes, Kearns, Patt, Whelan, and Wyman - 5; voting nay: Huth - 1.

Senior Planner Patrick Hudson presented staff report on Resolution No. 9899-R9: A

Resolution Of Protest (CC7BA Case No. 14-AM-98 - Rezoning Request By Jan and Robert Waller)

stating that the petitioners are requesting the rezoning of a .36 acre tract on their property at 1604 E.

Olympian Road from County R-5 to AG-2 to allow a single family dwelling on that property. This property is in the County.

Following debate, Alderwoman Wyman moved to adopt Resolution Of Protest (CCZBA Case No. 14-AM-98 - Rezoning Request By Jan and Robert Waller). The motion was seconded by Alderman Whelan and failed by a voice vote.

#### **ADJOURNMENT**

There being no further business to come before the Council, Mayor Pro Tem Hayes declared the meeting adjourned at 7:55 p.m.
