E. REPORTS OF STANDING COMMITTEES

1. Committee Of The Whole

a. Motion On Collector Street Streetlighting Recommendations

Alderwoman Patt made a motion to approve staff's recommendations described in the October 24, 1998 memo for specific Areas 1, 2, 3 and 4, along with the miscellaneous recommendations, and rejecting Alternatives 1 and 2. Alderwoman Wyman seconded. As a point of clarity, Alderwoman Patt stated that Areas 1 (Race to Washington) and 3 (Florida from Busey to Race) would have a .38 ft. candle lighting level with L72 fixture, Area 2 (Race, Pennsylvania, Cottage Grove) would have a .20 ft. candle lighting level with L72 fixture, and Area 4 (Green from Busey to Race) would be a double-headed L72 fixture using 70-watt lamps with slightly closer spacing and provide a .46 ft. candle lighting level. This motion also includes the recommendation that the tempered glass lenses be used in the L72 fixture; that the decorative chimney be added; and that electrical outlets be added.

This would exclude any of the tall poles that were suggested in Alternatives 1 & 2.

Glenn Berman (Assistant Public Works Director) explained to Council that Pennsylvania from Lincoln to Race, and Cottage Grove from Main to Oregon would <u>not</u> be the L72. Those areas would be the standard concrete ornamental poles with round white globes lit to a .20 candle lighting level.

The intent of the motion is to endorse the staff recommendation and not the proposals in Alternatives 1 and 2 that involve the tall poles.

The motion carried by voice vote.

Disposition: The Council upheld staffs' recommendation for Areas 1, 2, 3 & 4, and rejected proposals made in Alternatives 1 & 2.
