## d. Res. No. 1999-04-017R: Resolution In Support Of Keeping Jobs In The City Of Urbana

Alderwoman Wyman made a motion to adopt the resolution. Alderwoman Huth seconded.

Following debate, Alderman Whelan made a motion to amend the resolution to eliminate the NLRB (National Labor Relations Board) commentary in the "Whereas" clauses and say that "The City of Urbana hereby strongly requests that SuperValu reconsider its decision to contract out its trucking operations so that these jobs can be retained here in Urbana." The motion failed due to lack of a second.

Following further debate, Mayor Satterthwaite asked Alderman Hayes to take the chair (8:15 p.m.). Mayor Satterthwaite entered debate.

Alderman Whelan requested a roll call vote on the motion. The vote was as follows:

## H. NEW BUSINESS

1. Res. No. 1999-04-016R: A Resolution Of Protest Against A Proposed Text Amendment To The Champaign County Zoning Ordinance

April Getchius (Community Development Director) presented the staff report.

Earlier this evening, Alderwoman Patt distributed a copy of the resolution indicating amendments she would like made. Alderwoman made a motion to adopt the resolution with the amendments she had cited in the third "Whereas" clause, and add a Section 4. The amendments would read as follows: [amendments are underlined]

"WHEREAS, despite the recommendation of the Plan Commission, the Urbana City Council, having duly considered all matters pertaining thereto, finds and determines that the proposed zoning text amendment is not in the best interests of the City of Urbana because the definition of Sexually Oriented Businesses in said text amendment is fundamentally different than the Urbana Zoning Ordinance definition of Adult Entertainment Use in that the proposed text amendment would allow restricting the locations of business establishments on the basis of the content of materials sold, rather than on the basis of the practice of excluding entry of minors by virtue of their age."

"Section 4. That the Urbana City Council would not protest an amendment to the Champaign County Zoning Ordinance to provide for Sexually Oriented Businesses if, by definition, the land use 'Sexually Oriented Businesses' applies only to establishments which exclude entry of minors by virtue of their age." Urbana City Council Minutes: April 19, 1999 Page 6 Alderman Taylor seconded. Debate ensued. Steve Moser (Champaign County Board Chair) was present at the meeting and offered input. Following debate, Mayor Satterthwaite asked Alderman Hayes to take the chair (9:09 p.m.). Mayor Satterthwaite entered debate. Alderman Whelan requested a roll call vote on the motion. The vote on the motion was as follows: Hayes - Aye Taylor - Aye Huth - Aye Whelan - Nay Kearns – Aye Wyman - Aye Patt - Aye **Disposition:** The motion carried by roll call (6-aye:1-nay).

Resolution No. 1999-04-016R, A Resolution Of Protest Against A Proposed Text Amendment To The Champaign County Zoning Ordinance", was adopted by Council.

Mayor Satterthwaite resumed the chair at 9:12 p.m.
