RE: 2002 MFT Resurfacing Resolution

Introduction

Attached is the proposed resolution and supporting documentation for this year's Motor Fuel Tax (MFT) Resurfacing Project to be considered at the March 18th City Council meeting. All proposed work is based upon needs identified during the street rating process and as coordinated with the Capital Improvement Plan.

The street sections to be resurfaced are shown on the attached location map. Work will include pavement patching, milling and resurfacing, curb & gutter, and sidewalk repair. In this years program there is also work to be done at Crystal Lake Park for the Urbana Park District. As in years past we will provide engineering services to the Park District in setting up and monitoring the project, with construction costs to be reimbursed by the Park District to the MFT account.

Budget Impacts

The project is estimated at \$857,000 which includes the Park District work of approximately \$43,000. The total resolution amount is presented for \$900,000.

Recommendation

It is recommended that the Resolution for Improvement by Municipality Under the Illinois Highway Code (FY 2002 MFT Resurfacing Contract) in the amount of \$900,000 be approved by the City Council at the March 18, 2002 meeting.

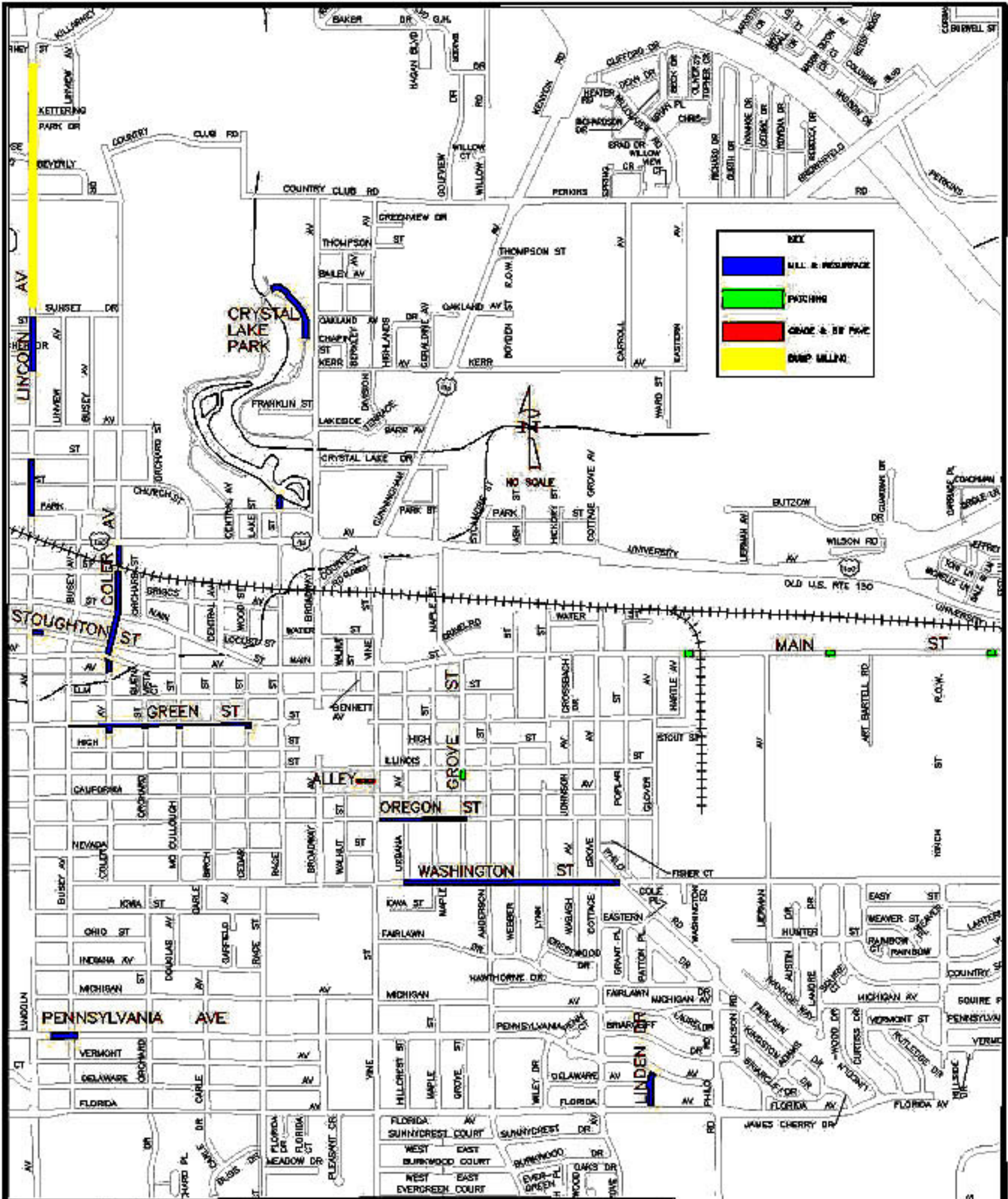
