**RE:** Ordinance from Traffic Commission

Attached is an ordinance for your approval from action taken by the Traffic Commission.

The ordinance (Schedule J) is for the establishment of a “No Parking This Side of Street” zone on both sides of Lincoln Avenue from Interstate 74 to Somer Drive, Anthony Drive from Oak Street to 410 West Anthony, and Kenyon Road from Oak Street to Gregory Street. This is necessary due to problems of semi-trucks parking on these streets and blocking traffic. These three streets do not have adequate width to accommodate moving traffic and parking. The trucks are waiting to unload in the early morning hours at the SuperValu warehouse. Trucks previously parked on the east side of Lincoln Avenue in a gravel lot which has now been fenced in by the owners. In addition SuperValu is expanding their building and parking spaces were temporarily lost as a result. Once construction is complete the parking shortage will be improved.

The Traffic Commission has considered these locations at its Sept. and Oct., 2002 meetings and recommends that the ordinance be approved.

ORDINANCE NO. 2002-10-127

**AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS**

(Lincoln Avenue, Anthony Drive, Kenyon Road)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

SECTION 1: That Schedule J of Section 23-183, entitled "Parking Prohibited at All Times on Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between Street</u>	<u>&amp; Street</u>	<u>Side of Street</u>
Lincoln Avenue	Interstate 74	Somer Drive	Both
Anthony Drive	Oak Street	410 West Anthony Drive	Both
Kenyon Road	Gregory Street	Oak Street	Both

SECTION 2: All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

SECTION 3: This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

SECTION 4: The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.

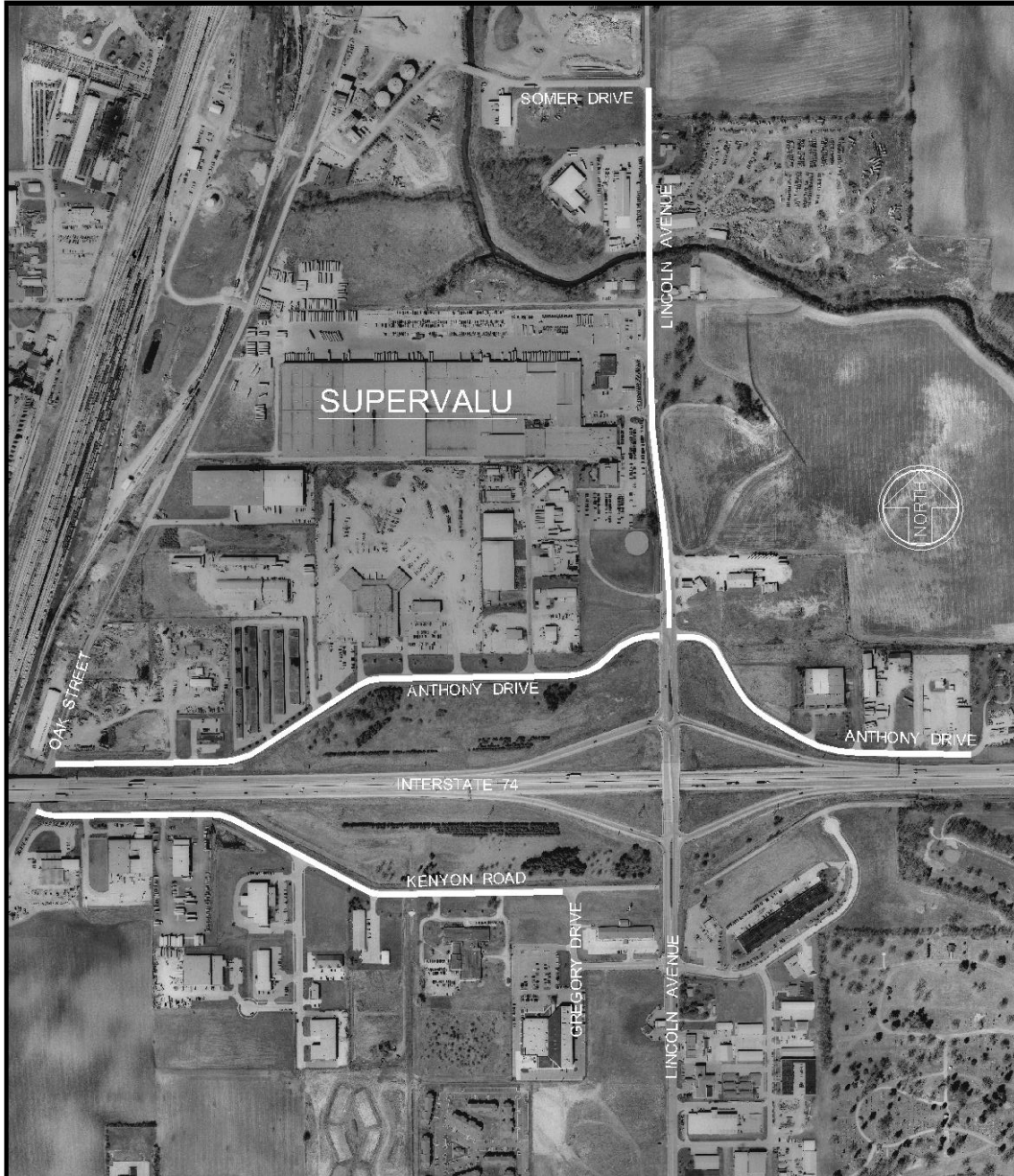
