**RE:** Ordinances from Traffic Commission

Attached are three ordinances for your approval from action taken by the Traffic Commission.

The first ordinance (Schedule K) is for the prohibition of parking on the south side of Nevada Street from Walnut Street to Vine Street from Monday thru Friday. This was requested by residents of that street with full agreement from all property owners. When school is in session vehicles are parked on both sides of the narrow street thereby creating a hazard and congestion.

The second ordinance (Schedule M) is for the establishment of a tow away zone on the east side of Cottage Grove Drive from 290 feet south of Burkwood Drive to 305 feet south of Burkwood Drive. This was requested from residents of the area because vehicles were occasionally blocking the accessibility ramp to Crestview Park. This will enable enforcement of the yellow zone that is already present.

The third ordinance (Schedule H) is for the placement of stop signs on some of the newly constructed streets in Beringer Commons subdivision. These signs are warranted by the Manual of Uniform Traffic Control Devices under Section 2B.05. The two locations are eastbound Slayback Drive at Beringer Circle and eastbound Beringer Circle at High Cross Road.

The Traffic Commission has considered and recommends the attached ordinances.

**AN ORDINANCE AMENDING SCHEDULE K OF SECTION 23-184 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING DURING CERTAIN HOURS ON CERTAIN STREETS**

**(Nevada Street)**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule K of Section 23-184, entitled "Parking Prohibited During Certain Hours On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle on the designated days or times:

<u>Street</u>	<u>Side of Street</u>	<u>Between</u>	<u>Days</u>
Nevada Street	South	Vine Street and Walnut Street	Monday through Friday

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
