**RE:** **Parking Restrictions on Nevada, Between Vine Street  
and Walnut Street**

As requested at the January 13 Committee of the Whole Meeting, this memorandum confirms all residents/property owners have been notified on the subject block. All residents/property owners are in support of the action recommended.

The Urbana High School principal, Mr. John Woodward, has been contacted and because of safety concerns supports the proposed parking restrictions.

The president of the Urbana High School student senate has been contacted, and to date we have not heard a response from the student senate. Representatives of the student senate may voice any concerns at this Monday night's meeting.

**AN ORDINANCE AMENDING SCHEDULE K OF SECTION 23-184 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING DURING CERTAIN HOURS ON CERTAIN STREETS**

**(Nevada Street)**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule K of Section 23-184, entitled "Parking Prohibited During Certain Hours On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle on the designated days or times:

<u>Street</u>	<u>Side of Street</u>	<u>Between</u>	<u>Days</u>
Nevada Street	South	Vine Street and Walnut Street	Monday through Friday

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
