**SUBJECT:** Plan Case 1896-S-04, Final Subdivision Plat for Landis Farm Phase II.

---

**Introduction**

The Weisiger Family Trust has submitted a final plat for Phase II of Landis Farm Subdivision. The plat would create 40 lots to the east of Phase I, which is currently under construction. The plat would dedicate the continuation of Milford Drive and Newport Drive from their existing stubs. The plat would also dedicate Goodfield Drive as a new street.

**Background**

City Council approved an annexation agreement and preliminary subdivision plat for Landis Farm in September 1999. The approval was for a total of 83 single-family lots on approximately 30 acres. Phase I was approved and recorded in December 2000 for 22 lots. The developer expects to begin development of Phase II subsequent to Council approval and recording of the final plat. All of the new homes are eligible for the “Build Urbana” Tax Rebate Program.

**Discussion**

As with any request for a final subdivision plat, the proposed plat has been sent to the appropriate agencies for their review and approval. At this time there are no significant agency comments regarding the plat.

*Access*

All the new lots will front on public local level roadways. Milford Drive, Newport Drive and Goodfield Drive will all contain 60-foot rights-of-way and will be improved with a 28-foot public street built to the standards of the Subdivision and Land Development Code. Sidewalks will be provided on both sides of all streets.

### *Drainage and Sewers*

The Landis Farm Preliminary Plat identified two lots designated for stormwater detention. All of the runoff generated from the development will drain to these lots. These two lots were platted as part of the Phase I and will accommodate runoff from all the lots developed as part of Phase II. The engineering plans for the detention basins were previously reviewed and approved by the City Engineer. Construction plans for Phase II will also be reviewed by the City Engineer to assure proper site grading and drainage.

### *Utilities*

The site is currently adequately served by all necessary utilities.

### *Waivers*

There are no additional waivers requested at this time.

## **Summary of Findings**

### ***For Plan Case 1896-S-04:***

1. The proposed final plat is consistent with the approved preliminary plat as it relates to the road network, access, drainage and utilities.
2. The proposed final plat is consistent with the Comprehensive Plan land use and roadway designations for the site.
3. The final plat is consistent with the requirements of the Urbana Subdivision and Land Development Code, with the exception of waivers previously granted.
4. On October 4, 1999 the Urbana City Council approved an annexation agreement and preliminary plat for Landis Farm Subdivision under Ordinance 1999-09-098 and 1999-10-105 respectively. The requested final plat is consistent with the provisions of those ordinances.
5. There are no additional requested waivers to the Urbana Subdivision and Land Development Code.

## **Options**

The City Council has the following options for this case. In Plan Case 1896-S-04, the City Council may:

- a. Approve of the proposed final plat.

- b. Deny the proposed final plat.

**Staff Recommendation**

Staff recommends that the City Council approve the requested final plat for Plan Case 1896-S-04.
