RE: *Motor Fuel Tax Construction Resolution for Colorado Avenue Improvement*

Introduction

Attached is the proposed resolution and supporting documentation for the Colorado Avenue Motor Fuel Tax (MFT) Construction Resolution to be considered at next Monday's (April 24th, 2006) Committee of the Whole meeting. All proposed work is based upon needs identified in the Capital Improvement Plan.

The project consists of the reconstruction of Colorado Avenue from Philo Road to Prairie Winds Drive. See attached map. The project specifically consists of the construction of a concrete pavement, concrete curbs and gutters, concrete sidewalks, a concrete bikepath, storm sewers, associated drainage structures, and pavement markings. Other improvements planned are the installation of ADA sidewalk ramps at all corners of the Colorado Avenue and Philo Road intersection, and the northwest corner of Colorado Avenue and Prairie Winds Drive and the widening of the existing sidewalk into a bikepath adjacent to the Prairie Winds Assisted Living Development. Material testing services for the project will be performed by a consultant and their fees are being paid from the MFT fund. The project limits are shown on the attached map.

Fiscal Impact

The total cost of the project is estimated at \$340,000 of which \$180,000 is from MFT funds and the remaining \$160,000 is from Capital Replacement and Improvement funds. The MFT resolution for \$180,000 includes construction cost contingencies and material testing.

Council Action

The City Council is asked to approve the attached Resolution for Improvement by Municipality Under the Illinois Highway Code in the amount of \$180,000.

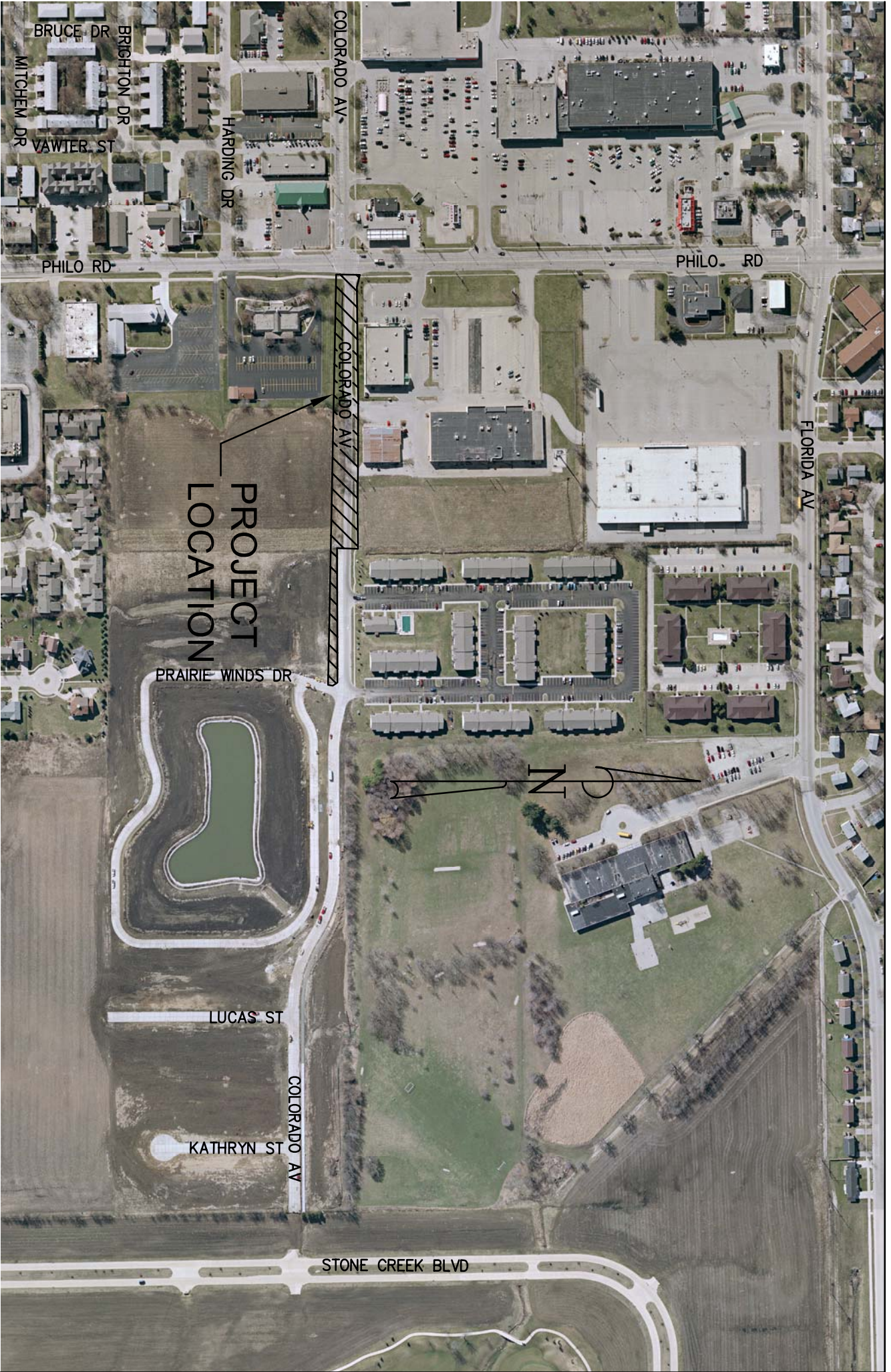
and shall be constructed 40 feet wide and be designated as Section 06-00427-00-PW
