RE: Ordinance from Traffic Commission

Attached is the revised ordinance for your approval from action taken by the Urbana Traffic Commission.

The ordinance (Schedule J) establishes a curb loading zone on Mumford Drive and Anderson Street from Monday to Saturday. Currently, there are loading zones located along those streets. Members of the church located at the northeast corner of Mumford Drive and Anderson Street asked to have permission to park in the loading zone areas on Sundays when services are being held. Parking was allowed on Sundays on a trial basis for ninety days. During that time, no complaints were received by the Police Department or by the Public Works Department. In the ordinance presented at the December 8th Committee of the Whole meeting, the ordinance incorrectly stated that the loading zone would have a 30-minute time limit; the time limit should be 15 minutes.

The Traffic Commission considered this location at its November 2008 meeting and recommends that the ordinance be passed by the City Council.

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE ESTABLISHING CURB LOADING ZONES ON CERTAIN STREETS

(Mumford Drive; Anderson Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street which shall be established as a loading zone on the designated days or times:

<u>Street</u>	<u>Side of Street</u>	<u>Days</u>	<u>Hours</u>	<u>Duration</u>
Mumford Drive from the east right-of-way line of Anderson Street to the west the right-of-way line of Lynn Street	South	Monday through Saturday	All day	15 minutes
Anderson Street from the south right-of-way line of Mumford Drive to the north of the right-of-way line of Eliot Drive	East	Monday through Saturday	All day	15 minutes

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the

effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

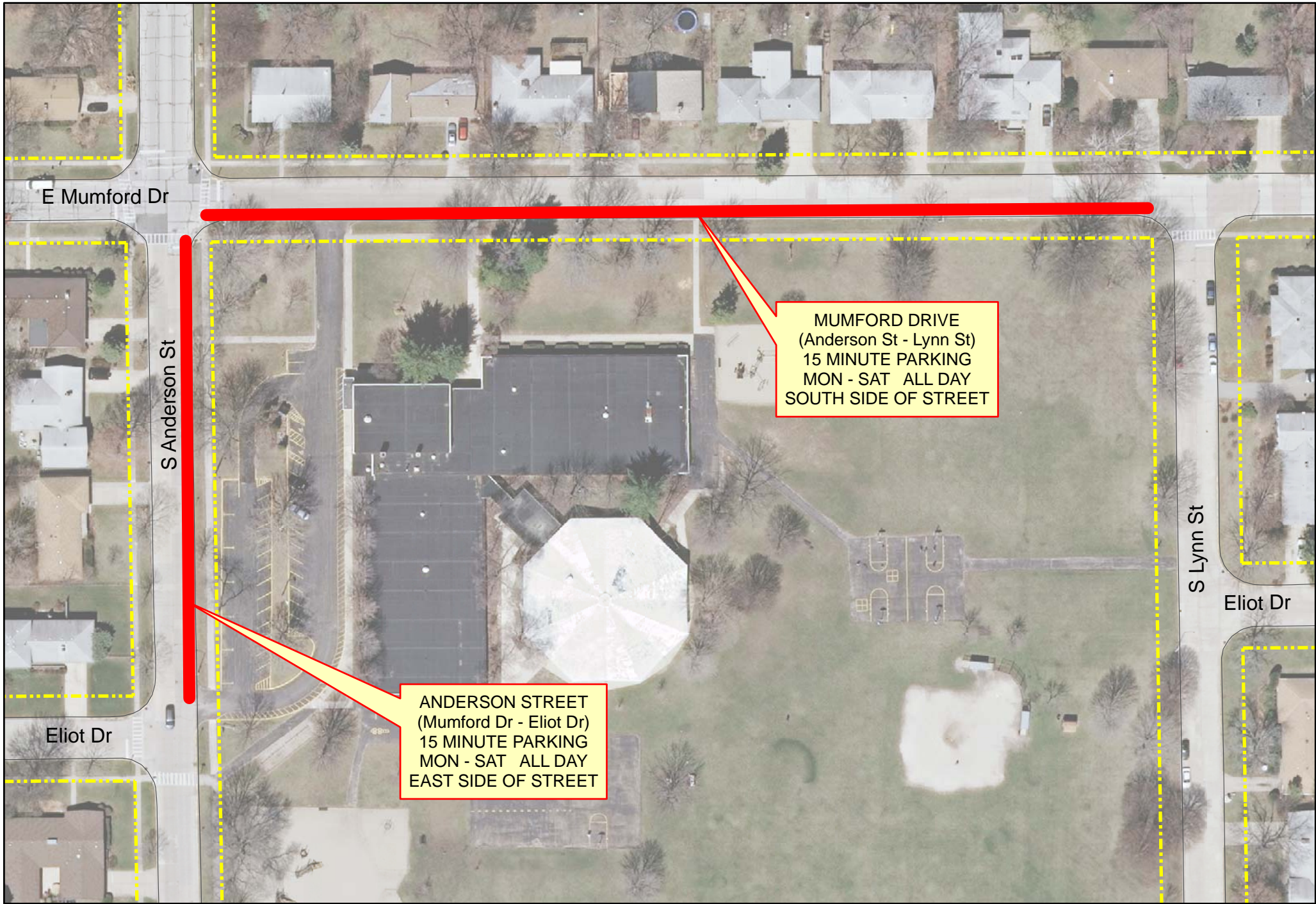
