

ORDINANCE NO. 2010-10-088

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES AFL-CIO, COUNCIL 31, LOCAL 1331, FOR THE TERM BEGINNING JULY 1, 2010, THROUGH JUNE 30, 2011

WHEREAS, the duly authorized representatives of the City of Urbana in good faith have negotiated a one-year collective bargaining agreement ("Agreement") with the American Federation of State, County and Municipal Employees AFL-CIO, Council 31, Local 1331 ("AFSCME"), concerning wages, hours, terms, and other conditions of employment for the term of July 1, 2010, through June 30, 2011; and

WHEREAS, the Agreement has been lawfully and properly ratified by the membership of AFSCME Local No. 1331; and

WHEREAS, the Mayor and City Council find that the best interests of the City are served by executing the Agreement.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of Urbana, Champaign County, Illinois, as follows:

Section 1.

That the collective bargaining agreement between the City of Urbana and AFSCME Local No. 1331, in substantially the form of the copy of said Agreement attached hereto and hereby incorporated by reference, be and the same is hereby authorized and approved.

Section 2.

That the Mayor of the City of Urbana, Illinois, be and the same is hereby authorized to execute and deliver and the City Clerk of the City of Urbana, Illinois, be and the same is authorized to attest to said execution of said Agreement as so authorized and approved for and on behalf of the City of Urbana, Illinois.

Section 3.

This Ordinance is hereby passed by the affirmative vote, the

"ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.

AGREEMENT

AFL-CIO, Council 31, Local 1331

The CITY OF URBANA, ILLINOIS and the AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES AFL-CIO, COUNCIL 31, LOCAL 1331 ("AFSCME") hereby agree to extend all of the terms of the July 1, 2006 through June 30, 2010 Collective Bargaining Agreement up to and through June 30, 2011. It is further agreed, if as a result of the current sets of negotiations with either the Fraternal Order of Police and/or the International Association of Fire Fighters representing certain City of Urbana employees, the Union(s) and the City agree to a new collective bargaining agreement, which contains either an hourly or percentage wage increase or contains employee health insurance premium contributions for the same health insurance benefits that are more favorable to members of their bargaining unit than what is contained in the parties' extended Collective Bargaining Agreement, the City will extend the same wage increase or employee health insurance premium contributions on the same terms, as applicable, to members of the AFSCME bargaining unit.
