The City Council of the City of Urbana, Illinois met in regular session Tuesday,\* January 22, 2013 in the Council Chambers at the Urbana City Building, 400 S. Vine St. (\*Monday was a holiday, Martin Luther King Jr. Day). There being a quorum, Mayor Prussing called the meeting to order at 7:00pm. In the course of the meeting, a Closed Session was held:

Alderman Smyth made a motion to go into a closed session at 8:50 p.m. to discuss Property Acquisition Issues Pursuant to 5 ILCS 120/2(c)(5). Alderman Jakobsson seconded.
