

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL  
TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Florida Avenue between Race Street and Busey Avenue)

WHEREAS, the City of Urbana is improving its streets and sidewalks for all modes of transportation throughout the City; and

WHEREAS, a certain street, namely Florida Avenue, must be designated as a street where parking is temporarily prohibited in order to provide and enhance the safety to those users of that street; and

WHEREAS, the City of Urbana Traffic Commission conducted public hearings on October 13, 2015, and November 10, 2015, regarding the temporary prohibition of parking at all times on said street; and

WHEREAS, the prohibition of parking on certain streets is authorized pursuant to the City's ordinances including Chapter 23, Article XIV, Section 23-183 *et seq.*;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times on Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by temporarily ADDING to that schedule the following portions of streets where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Florida Avenue	From the centerline of Race Street to the centerline of Busey Avenue	North Side

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. It is the intent of this Ordinance to temporarily prohibit parking provided for in this Ordinance to accommodate the existing pavement conditions and not to be construed as a permanent prohibition of parking on that section of said street.

Section 5. No citation for violation of the change of parking restrictions provided for in this Ordinance shall be issued until the appropriate signage shall be fully implemented and in place.

Section 6. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.
