SUBJECT: DRAFT CITY OF URBANA AND URBANA HOME CONSORTIUM (CHAMPAIGN/URBANA/CHAMPAIGN COUNTY) FY 2020-2024 CONSOLIDATED PLAN

Description

The City of Urbana, Grants Management Division, has prepared a DRAFT CITY OF URBANA AND URBANA HOME CONSORTIUM (CHAMPAIGN/URBANA/CHAMPAIGN COUNTY) FY 2020-2024 CONSOLIDATED PLAN (Consolidated Plan). The Consolidated Plan must be submitted to the US Department of Housing and Urban Development (HUD) by May 15, 2020, in order for the City of Urbana to continue to receive Community Development Block Grant (CDBG) and Home Investment Partnership Act (HOME) funding.

Issues

The issue is for the City Council to review the Draft Consolidated Plan for FY 2020-2024 and provide input regarding the proposed Plan. Input received during the upcoming 30-day public comment period will be incorporated into the Plan along with recommendations from the Urbana City Council. At its March 24, 2020, meeting, the Community Development Commission (CDC) will be asked to make a final recommendation to the Urbana City Council regarding the Plan.

Background and Discussion

As a recipient of CDBG and HOME entitlement funding from HUD, the City of Urbana and the Urbana HOME Consortium are required to develop a Five-Year Consolidated Plan that guides program planning and implementation. HUD provides the following summary statement concerning the Consolidated Plan:

The overall goal of the community planning and development programs covered by this part is to develop viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities principally for low- and moderate-income persons. The primary means towards this end is to extend and strengthen partnerships among all levels of government and the private sector, including for-profit and non-profit organizations, in the production and operation of affordable housing.

The City submits the Consolidated Plan, Annual Action Plan, and Annual Performance Report in partnership with members of the Urbana HOME Consortium: City of Urbana, City of Champaign, and Champaign County Regional Plan Commission. The City of Urbana serves as the lead entity for the Urbana HOME Consortium. The City's current Consolidated Plan ends on June 30, 2020. Attached is a copy of the Draft Consolidated Plan for review and comment. The demographic

information/data, housing/community development information, and related background information are based on information from the 2010 Census and other resources.

A 30-day public comment period will run from March 1, 2020, through March 31, 2020. A public hearing to accept comments on the Draft Consolidated Plan was held on February 25, 2020, and another will be held on March 24, 2020, prior to the CDC meeting.

The creation of the Consolidated Plan included many community partners including Housing Authority of Champaign County, CU Public Health District, and Champaign County Continuum of Service Providers to the Homeless. The Cities went through an extensive data collection and public input process along with reviewing data from the 2010 Census and 2011 – 2015 Comprehensive Housing Affordability Strategy (CHAS) data. CHAS data demonstrates the number of households in need of housing assistance. A review of existing community plans were utilized for resources such as the Housing Authority of Champaign County Move to Work Plan, Champaign Urbana Public Health Improvement Plan, Analysis of Impediments to Fair Housing Choice, and the State of Illinois Disaster Recovery Plan.

The City started public outreach in July of 2019 that will continue through the adoption of the plan. A citizen survey was available both electronically and on paper, and focus group meetings and public input meetings were all held throughout both communities. The online survey was shared through Cities' websites, UPTV, and social media. The survey was distributed through key partners and networks, too. Over 130 survey responses were received.

Through the public input and review of data, the following Community Development and Housing Needs were identified as high priority:

Community Development High Priority Needs:

Public Facilities Funding to support infrastructure improvements for lighting, drainage, roads, and parks in low-income census tracts.

Public Services Funding to support programs for seniors, homeless, and youth (after school and education opportunities). Neighborhood clean-ups and transitional housing are identified needs as well. Public Services funding is capped at 15% of CDBG annual allocation.

Economic Development Funding to support programs or services that create economic opportunity and jobs in low- and moderate-income neighborhoods. This may include improvements to small businesses in Community Development Targeted neighborhoods.

High Priority Housing Needs:

Provide Affordable Housing Opportunities for Low- and Moderate-Income Households Funding may be used to provide owner-occupied housing rehabilitation programs, Rental Assistance (Tenant Based Rental Assistance), down payment assistance, and transitional housing. Assistance to developers to build affordable housing may be provided, too.

Reducing Exposure to Lead-Based Paint Funding may support education, testing, and rehabilitation of housing with lead-based paint.

Support the Continuum of Service Providers to the Homeless Funding may support collaboration with service providers to address homeless needs, creation of affordable housing units, permanent supportive housing units, as well as general outreach to the homeless community.

Staff will continue to do public outreach and education seeking public input. Outreach to community partners and stakeholders will continue through finalization of the plan. The draft Consolidated Plan and Annual Action Plan will be published for public comment beginning on March 1, 2020. Copies will be provided at the Urbana Public Library, City Clerk's office, and Community Development Department. Public hearings were held at the February 25, 2020, and will be again at the March 24, 2020, CDC meeting. The public comment period will close on March 31, 2020. The Consolidated Plan and Annual Action Plan will be presented to the Committee of the Whole at the April 6, 2020, meeting for submission to Council for final approval. The adopted plan must be submitted to HUD by May 15, 2020.

Fiscal Impact

There are considerable fiscal impacts associated with the preparation of the FY 2020-2024 Consolidated Plan. The Consolidated Plan will guide the annual expenditure of an estimated \$475,000 in CDBG funding and \$750,000 in HOME funding. The main impact of the Consolidated Plan is that it can influence funding availability and utilization of CDBG and HOME funding. If a proposed project is not consistent with the goals and strategies of the Consolidated Plan, the project could not be funded with CDBG or HOME funding, unless the Consolidated Plan is amended to include the project.

Failure to submit the Consolidated Plan to HUD by the May 15, 2020, deadline could result in a significant delay in accessing CDBG and HOME funds, which would create a financial burden for the City to advance funds for these programs.

Recommendation

Staff recommends that the Urbana City Council review and provide comments on the Draft City of Urbana and Urbana HOME Consortium FY 2020-2024 Consolidated Plan that will aid staff with preparing the final FY 2020-2024 Consolidated Plan.



Consolidated Plan Online Survey Results

Between July 5, 2019 and September 5, 2019, an online community survey was open to residents of Champaign County. Anyone unable to complete the survey online could complete a paper survey and return it to the City of Urbana Community Development Services.

The survey was shared on the City of Urbana's website and Facebook page and the City of Champaign's Facebook page. The survey was sent to the Housing Authority of Champaign County, Habitat for Humanity of Champaign County, Champaign County Continuum of Service Providers, United Way of Champaign County, Community Reinvestment Group, Urbana City Council Members

Flyers were taken to several community events: Champaign County Community Coalition, Champaign-Urbana Days, Urbana's Market at the Square, Urbana Neighborhood Nights, and Salt and Light.

Survey Respondents:

85 respondents completed the survey—either online or on paper. The majority of survey respondents (70%) have lived in their neighborhoods for four years or more. Homeowners accounted for 83% of respondents and 66% of participants were female. Moreover, survey respondents had an average household income of \$88,000.

- 74% identified as non-Hispanic white
- 59% married or living with a partner
- 84% Employed full time
- 96% were not veterans
- 90% identified as not having a disability
- 39% held bachelor's degrees
- 25% held master's degrees

Infrastructure:

Street conditions and lack of street lights were major concerns to participants. 45% of respondents said street lighting in their neighborhood needs improvements, while another 22% of respondents said street lighting does not exist in their neighborhoods. Throughout the entire survey, 103 opened ended responses were collected (those saying "N/A" or "None" were excluded from this count), and 15 of those comments were related to insufficient street lighting in respondents' neighborhoods.

Community members were also concerned about the quality of transportation infrastructure. 64% of respondents said that streets/roads need improvements. This is a large concern considering 80% of respondents said they used a personal car as their main mode of transportation. Another 48% of respondents said sidewalks in their neighborhoods need improvements, with 60% of survey takers walking as their second most-used mode of transportation.

Business Services:

Many respondents indicated a desire for public art in their neighborhoods (63%). Lack of youth employment opportunities was another concern. Half of the survey participants said these types of opportunities were needed in their neighborhood. Moreover, 46% of respondents said business attraction was needed.

The open-ended prompt, "Please list other types of businesses needed in your neighborhood" generated responses related to the desire for nearby grocery stores and easier access to fresh food. Respondents were also interested in having mixed-use neighborhoods, some were also interested in mixed-use developments.

Housing:

Majority of survey respondents (61%) think housing costs are reasonable in their neighborhoods. However, more than half of respondents do not think there is sufficient housing for low-income households, seniors, persons with disabilities, persons with special needs, households transitioning from homelessness, and persons with criminal backgrounds. Moreover, the survey showed that community members "strongly agreed" there was enough student housing (60%) in Champaign County. While many respondents may not live in low-income neighborhoods, or may not require low-income housing for themselves, they do recognize there is a need for other residents in the community.

Community members indicated a strong need for many housing programs in their neighborhoods.

- 1. Weatherization/Energy efficiency: 77%
- 2. Repair/Rehabilitation on owner occupied units: 65%
- 3. Rental Housing for Seniors: 61%
- 4. Homebuyer Education and Financial Literacy: 58%
- 5. Downpayment Assistance: 55%
- 6. Rental Housing Repair/Rehabilitation: 53%
- 7. Rental Housing for People with Disabilities: 52%
- 8. Accessibility Improvements: 51%
- 9. Modifications for Aging Adults: 51%
- 10. Lead-Based Paint Testing/Removal: 48%
- 11. Fair Housing Enforcement/Education: 47%
- 12. Rental Payment Assistance/Vouchers: 46%
- 13. Rental Housing for Those Transitioning Out of Homelessness/Currently Homeless: 46%

Homelessness is a major concern to residents of Champaign County. Almost 70% of respondents indicated that there was a high need in the community for facilities and services for women and children experiencing homelessness and families with children experiencing homelessness. A little over 60% of survey respondents indicated a high need for facilities and services for single women and unaccompanied youth experiencing homelessness. 58% of respondents thought there was a high need for single men experiencing homelessness to have access to resources.

Neighborhood Services:

One-third of respondents indicated that youth services were needed in their neighborhood. There were also concerns that more services for persons with disabilities and senior citizens were needed.
