Leslie (Peter) McFarland

Peter McFarland is a 38 year resident of the City of Urbana and is recently retired after working as a technical engineer at WCIA-TV for over 25 years. He currently serves as Vice Chair of the Deacon's Ministry at Pilgrim Missionary Baptist Church, as a board member of the Boy Scouts of America Scoutreach and is a leader in First String, Inc. The latter is a non-profit organization that involves youth, especially males ages 5-12 years in Little League Baseball and other programming.

Past community board service included approximately 7 years with the C-U Boys and Girls Club and 3 years with the Stevens Family YMCA. Peter McFarland's primary interest is in working with youth in our community through programming and mentoring.

Peter McFarland has worked closely with families who are likely to be served by the Housing Authority of Champaign County and is particularly interested in supporting the HACC's YouthBuild Program, which provides on-the-job training, resources, and support for young people ages 16-24.
