OLD BUSINESS

An Ordinance Amending Chapter Twenty-Four Of The Code Of Ordinances, City Of Urbana, Illinois Prescribing Regulations For Rates Charged To Cable Television Subscribers was on the floor from the previous meeting.

Alderman Whelan arrived.

Alderman Pollock moved to amend the ordinance as follows:

- Add the word "and" to the end of the second paragraph.
- Section 24-123. Initial review of basic cable rates., add the letter "s" to the word "form".
- Section 24-123(B), replace the word "An" with "Any" in the first line; in the fourth line add the word "filed" following the word "be".
- Section 24-123(3), delete from the end "Public notice will be given by advertisement once in the official newspaper of the city".
- Add "Section (G) Continuing jurisdiction. The City reserves the right to reconsider its decision concerning the initial basic cable rates based upon newly discovered information or changes in federal law."
- Section 24-124(A) delete from the end "This notice may not be given more often than annually and not until at least one year after the determination of the initial basic cable rates."
- Section 24-124(B) replace the word "An" with "Any" in the first line; add the word "filed" following the word "be".
- Section 24-124(E) add to the end, "and the City Council must give public notice of its decision."
- Section 24-124 add "(H) Continuing jurisdiction. The City reserves the right to reconsider its decision concerning an increase in the basic cable rates based upon newly discovered information or changes in federal law."

Alderman Taylor moved to adopt An Amendment To A Part Of The Zoning Ordinance Of The City Of Urbana, Illinois And The Zoning Map Of Urbana, Illinois (902 West Killarney Street) (Plan Case No. 1527-M-94 - Request to Rezone 901 West Kenyon Road from IN Industrial to B-3 General Business). (*This property was formerly 901 West Kenyon Road, the address has been changed to 902 West Killarney Street.*) The motion was seconded by Alderwoman Ryan.

Following debate, the motion to adopt the ordinance carried 7-0 by roll call vote. Voting aye were Members of the Council: Hayes, Patt, Pollock, Ryan, Singer, Whelan and Taylor - 7; voting nay: none.
