

**URBANA CITY COUNCIL MEETING
MONDAY, DECEMBER 2, 1996**

The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, December 2, 1996 at the Urbana School District Office at 205 North Race Street.

Present at the meeting were Members of the Council: Hayes, Kearns, Patt, Ryan, Taylor, and Whelan - 6; absent: Pollock - 1.

Also present were staff members: Tim Fitzpatrick, Bruce Walden, Jack Waaler, April Getchius, Bruce Stoffel, Phyllis Clark and Mayor Satterthwaite.

There being a quorum, the meeting was called to order at 7:30 p.m. by Mayor Tod Satterthwaite.

MINUTES OF PREVIOUS MEETING

Aldерwoman Ryan moved to approve the minutes of the November 18, 1996 regular meeting. The motion was seconded by Aldерwoman Patt. Alderman Whelan requested to amend the minutes to change on page 3 under Council Participation where he had discussed CRC. Alderman Whelan wanted it to be made clear that he had mentioned some problems they had in Champaign. Alderman Whelan stated that he had mentioned specifically that the material they had left had to be landfilled and it was Urbana's material. Alderman Whelan urged the Council to reconsider because of the possible cost of a million dollars for four years to save three weeks of landfill. Those numbers were rather

critical. There were no objections to the corrections. The motion, as amended, carried by a voice vote.

ADDITIONS TO THE AGENDA

Mayor Satterthwaite requested that the items under New Business, all which relate to Lincoln Mobile Home Park, be postponed until next week as Staff is still working on the relocation plan for residents. These items would also be discussed at the meeting on December 16, 1996. Final action would be scheduled for January 6, 1996. There was no objection.
