## URBANA CITY COUNCIL MEETING MONDAY, APRIL 17, 2000

The City Council of the City of Urbana, Illinois, met in regular session Monday, April 17, 2000 in the Council Chambers at the Urbana City Building.

#### A. APPROVAL OF MINUTES OF PREVIOUS MEETING

**April 3, 2000** - Alderwoman Kearns made a motion to approve the minutes of April 3, 2000. Alderwoman Huth seconded. The motion carried by voice vote.

#### B. ADDITIONS TO THE AGENDA

Alderman Hayes made a motion to amend Section 2.8(a) to read: "When FLSA non-exempt employees are required to be absent from work because of a non-job related court ordered subpoena, he/she will be compensated up to a maximum of four hours per calendar year and such compensation will be coded as regular duty. Where absence for such a court order exceeds four hours, said employee may elect to charge the absence to available accrued vacation or compensatory Urbana City Council Minutes: April 17, 2000 Page 3 of 6

> time. If there is no available accrued vacation or compensatory time, the employee's absence will be coded as authorized non-paid leave." Alderwoman Patt seconded. The motion carried by voice vote.
