1. CALL TO ORDER AND ROLL CALL

There being a quorum, Chair Hayes called the meeting of the Committee Of The Whole to order at 7:36 p.m.

2. ADDITIONS TO THE AGENDA AND STAFF REPORT

Mayor Satterthwaite requested to add two items to the agenda: 1) Closed Session to Discuss Probable Litigation; and 2) An Ordinance Revising the Annual Budget Ordinance (Litigation/Legal Expenses: New Tax Authority). There were no objections. These issues will appear as item numbers 14 and 15 respectively on the agenda.

3. APPROVAL OF MINUTES OF PREVIOUS MEETING

May 22, 2000 - Ms Wyman made a motion to approve the minutes of the meeting held May 22, 2000. Mrs. Kearns seconded.

Ms Patt noted corrections on pages 2 and 3 of the minutes. On page 2, paragraph 4, line 2 beginning "issues that way" should be corrected to read "issues that **weigh**". Page 3, paragraph 5, third sentence should read "**The** entire increase would be over a period of 4 years." Page 3, paragraph 6, first sentence should read "Following debate, Mr. Whelan **moved** to amend the motion to include the Council **salaries**." Page 3, paragraph 7, first sentence, correct "include" to read "**exclude**". There were no objections.

The motion to approve the minutes of May 22, 2000 carried by voice vote, as amended.

4. **PUBLIC INPUT**

Alex Foster, 809 High Street, addressed the Committee on the topic of tonight's ordinance concerning parking on High Street. He was confused about the description and wanted clarity on what part of the street the ordinance was pertaining to.

10. ORDINANCE NO. 2000-06-058: AN ORDINANCE AUTHORIZING THE PURCHASE OF CERTAIN REAL ESTATE (906 WEST EADS)

April Getchius (Community Development Director) presented the staff report.

Mrs. Kearns made a motion to send this item to Council with a recommendation for approval. Ms Patt seconded. The motion carried by voice vote.

11. ORDINANCE NO. 2000-06-059: AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA (CERTAIN LOTS IN BERINGER COMMONS SUBDIVISION)

Ms Getchius presented the staff report. Staff did not request any Council action at this time, but may request a special Council meeting. This meeting would convene just prior to the Committee meeting on June 26th in order to enact the annexation of some of the lots to comply with the July 1st property tax cycle. At present there is one petition submitted voluntarily on file. Staff is still working with property owners in the area who have not yet submitted their petitions.

The Committee took no action on this issue. Staff will present this item at a later date.

12. HOUSING AUTHORITY OF CHAMPAIGN COUNTY 5-YEAR PLAN AND MODERNIZATION REPORT

Ms Getchius presented the staff report. No Council action is required on this item. The U.S. Department of Housing and Urban Development (HUD) requires public housing authorities to prepare a 5-year plan. Local officials of the Housing Authority of Champaign County, Patricia Stebbins and Elawrence Davis, were present to describe this plan and its modernization requirement to the Committee.

13. DISCUSSION: AMENDMENT TO THE HOUSING AUTHORITY AGREEMENT TO INCLUDE RESIDENT REPRESENTATION

Ms Getchius presented the staff report. Mayor Satterthwaite noted that City of Champaign staff is not recommending the election process for representation on this board. Ms Getchius presented a copy of a memo from Champaign's City Manager, Steve Carter, for distribution to their City Council.

Housing Authority of Champaign County representatives Patricia Stebbins and Elawrence Davis were present to convey their comments to the Committee. Ms Stebbins explained their position on this issue, indicating that they do not wish to hold an election because of the cost and staff time that would be involved to see it through.
