The City Council of the City of Urbana, Illinois met in regular session at 7:30 p.m., Monday, August 7, 2000, in the Urbana City Council Chambers at 400 South Vine Street.

There being a quorum, Mayor Satterthwaite called the meeting to order at 7:31 p.m.

Public Works Director Bill Gray presented staff report on Resolution No. 2000-07-026R:

Resolution for Maintenance of Streets and Highways by Municipality Under the Illinois Highway

Code (FY 2000 MFT Street Resurfacing Contract) which covers a list of street to be resurfaced this year.

The number has been cut due to the concrete strike, which would cause a backlog and a higher cost. The streets that are being done this year are primarily asphalt.

Alderwoman Kearns moved to adopt Resolution No. 2000-07-026R: Resolution for

Maintenance of Streets and Highways by Municipality Under the Illinois Highway Code (FY 2000

MFT Street Resurfacing Contract). The motion was seconded by Alderman Hayes and carried 6-0 by roll

call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor and Wyman – 6; voting nay: none.

Assistant City Planner Libby Tyler presented staff report on Ordinance No. 2000-07-074:

An Ordinance Amending the Zoning Ordinance of the City of Urbana, Illinois (Addition of Definitions for "Athletic Training Facility, Non-Residential" and "Athletic Training Facility, Residential" – Plan

Case No. 1746-T-00) stating that this is a follow up to an ordinance adopted in May that amended the Zoning Ordinance to add a number of uses to the table of uses including the Athletic Training Facility, Non-Residential. As part of the motion to approve that ordinance there was a request to provide a definition for this use for the Zoning Ordinance. This definition has been recommended by the Plan Commission

Following debate, Alderwoman Patt moved to approve Ordinance No. 2000-07-074: An Ordinance Amending the Zoning Ordinance of the City of Urbana, Illinois (Addition of Definitions for "Athletic Training Facility, Non-Residential" and "Athletic Training Facility, Residential" - Plan Case No. 1746-T-00) as amended by the definition which was passed out at this meeting (see copy attached). The motion was seconded by Alderwoman Wyman and carried 6-0 by roll call vote. Voting aye were Members of the Council: Hayes, Huth, Kearns, Patt, Taylor, and Wyman - 6; voting nay: none.

Ms. Tyler presented staff report on Resolution No. 2000-07-027R: A Resolution of

Protest Against a Proposed Text Amendment to the Champaign County Zoning Ordinance (Six-Part

Omnibus Text Amendment Regarding Kennels, Veterinary Hospitals, Pet Cemeteries, Small-Scale

Fabricating Shops, Parking Requirements for Schools, and Clarification of Setback Requirements

for Rural Home Occupations - Plan Case CCZBA-219-AT-99. This case is omnibus text amendment,

which encompasses several text amendments. Staff has reviewed these amendments with respect to how
they affect the City and determined that there will be no negative affect on the City of Urbana. Plan

Commission recommends defeat of this protest.

Alderman Taylor moved to defeat Resolution No. 2000-07-027R: A Resolution of

Protest Against a Proposed Text Amendment to the Champaign County Zoning Ordinance (Six-Part

Omnibus Text Amendment Regarding Kennels, Veterinary Hospitals, Pet Cemeteries, Small-Scale

Fabricating Shops, Parking Requirements for Schools, and Clarification of Setback Requirements

for Rural Home Occupations - Plan Case CCZBA-219-AT-99. The motion was seconded by

Alderwoman Kearns and was defeated by voice vote.

Senior Planner Rob Kowalski presented staff report on Ordinance No. 2000-07-087: An Ordinance Amending the Zoning Ordinance of the City of Urbana, Illinois (Revisions to Article XII, Historic Preservation Ordinance - Plan Case No. 1750-T-00) stating that this is a request by the Zoning Administrator to amend the Historic Preservation Ordinance. There are many inconsistencies in the current ordinances, such as typos and grammar. Most of the changes relate to procedure and how applications are accepted and timing for hearings. These changes have been reviewed by the Historic Preservation and Plan Commissions.

City Attorney Jack Waaler requested an amendment so that Section 1 reads that "it is hereby amended to read as reflected in Exhibit A" .

Alderman Hayes moved to approve Ordinance No. 2000-07-087: An Ordinance

Chief Administrative Officer Bruce Walden and Community Development Director April Getchius reviewed the terms and categories of the annexation agreements.

The first category is the more commercial property, which includes Gerhardt property, Farm & Fleet property, and the Park Inn Property. While these properties are related to the Big Grove issue they are not related to the litigation.

The second category is the voluntary annexations of residences that are located near the Urbana Golf Course. There is also the category of clean-ups. such as Bakers Lane which is located in the Scottswood area and the Gallivan property near Oak Street.

Those annexations directly related to the Big Grove litigation are Routh Farm, Wheatley Annexation, and the stipulation voted on previously this evening by Council.

This action tonight does not force annex anyone in Edgewood or Scottswood. These properties would be excluded from the population of Big Grove.
