1. CALL TO ORDER AND ROLL CALL

There being a quorum, Chair Kearns called the meeting of the Committee Of The Whole to order at 7:35 p.m.

2. ADDITIONS TO THE AGENDA AND STAFF REPORT

There were no additions to the agenda.

Mayor Satterthwaite presented Ella Coleman (Transitional Housing Coordinator) with The Peggy Harris Memorial Recognition Award, recognized by the Parkland College Office of Women's Programs and Services. Ms Coleman received this award "For outstanding service and dedication to her profession and community."

Mayor Satterthwaite announced that a joint meeting of the School District, Park District, and City Council is scheduled for Wednesday, March 21, 2001 at 7:00 p.m. at the District 116 Administration Office located at 205 N. Race Street, Urbana. The topic for discussion will be University expansion and tax base erosion issues that result from University development.

3. APPROVAL OF MINUTES OF PREVIOUS MEETING

February 26, 2001 - Mr. Whelan made a motion to approve the minutes of the Committee meeting held February 26, 2001. Ms Patt seconded.

Ms Patt noted a correction to the minutes and moved to delete the second sentence on page 2, which reads, "Ms Patt suggested that this kind of thing was symbolism and should probably be done during the budget review." Ms Wyman seconded. The motion carried by voice vote.

Robin Cler, 1302 Eastern Drive, did not address the Committee but submitted a Public Input Card requesting that the record show her opposition to the current Human Relations Ordinance and desire that it be worded like the City of Champaign's.

Committee Member Input

Ms Huth reminded the audience and viewing public of the Illinois Power meeting going on now at the City of Champaign's City Building and urged them to attend. This meeting concerns the vegetation management tariff proposed by Illinois Power.

Ms Wyman indicated that she had received a few phone calls from constituents who were very pleased with the nuisance ordinance approved by Council last week.

Mr. Whelan indicated that he would be presenting the issue of amending the Human Rights Ordinance this evening, and requested that this issue be moved to the first part of the agenda. There was no support from other Committee Members to move this item up on the agenda. The agenda stands as presented.

Chair Kearns informed the Committee and public that there is now an information line ran by Champaign County Triad/S.A.L.T. (Seniors and Law Enforcement Together). This is an information line set up for senior citizens who feel they are victims of a fraud. This organization was established because many senior citizens feel more comfortable talking to a volunteer versus a law enforcement official.
