Deann Winn (Urbana Police Department/School Resource Officer) addressed the Committee with responses to questions and a description of the function of her position as SRO.

Ms Chynoweth requested that Chief Adair come back with a report on the types of criminal activities that take place at the school on a given day and how many involved arrests.
