URBANA CITY COUNCIL MEETING MAY 21, 2001

The City Council of the City of Urbana, Illinois, met in regular session Monday, May 21, 2001 in the Council Chambers at the Urbana City Building.

A. APPROVAL OF MINUTES OF PREVIOUS MEETING
