3. APPROVAL OF MINUTES OF PREVIOUS MEETING

<u>June 25, 2001</u> - Ms Patt made a motion to approve the minutes of the Committee meeting held June 25, 2001. Ms Chynoweth seconded. The motion carried by voice vote.

4. PUBLIC INPUT

Harold Wakeland, 2213 Combes, addressed the Committee on the topic of parking and campus development and expressed his opposition.

Carl Hill, 1913 Trails Dr., addressed the Committee with an update on the home trade show coming up this weekend as part of the "Build Urbana Home Parade", and encouraged everyone to attend and also look at the website (buildurbana.com).

April Getchius, Campus Planner representing the University of Illinois Planning Department, was present in support of Ordinance No. 2001-07-077 (An Ordinance Approving an Agreement Concerning the Vacation of Certain Rights-Of-Way), and informed the Committee that she would be available to answer any questions they may have.

5. ORDINANCE NO. 2001-07-071: AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT FOR USE OF RIGHT-OF-WAY (SUNNYCREST AVENUE BETWEEN ANDERSON STREET AND COTTAGE GROVE)

William Gray presented the staff report.

Ms Patt made a motion to send this item to Council with a recommendation for approval. Ms Huth seconded. The motion carried by voice vote.

6. UNIVERSITY OF ILLINOIS PARKING MASTER PLAN PRESENTATION

Pam Voitik (Assistant Vice Chancellor) and Mylinda Granger (Coordinator/Parking Business Operations) did a presentation on the proposed parking master plan. Ms Voitik also distributed a timeline of proposed construction along with a summary. The purpose of the planning study was to determine existing parking demand, evaluate parking adequacy in light of proposed facility development (Campus Master Plan), and development options for increasing parking supply to meet demand. Current demands indicated the need for parking for buildings.

This item did not warrant Council action at this time.

7. WEST URBANA STREET MARKING PROGRAM

Glenn Berman (Manager of Engineering & Administration) presented the staff report. Staff was asked to develop a program to place street markings for parking spaces at driveway entrances in the West Urbana neighborhood in order to try to reduce the incidence of on-street vehicles blocking driveways. James Kelly (Operations Manager) was also available to render staff support in answering questions.

Ms Patt made a motion to request that staff implement this street striping plan with Alternative #1, to exclude Green and Orchard Streets. Ms Huth seconded.

In response to Ms Chynoweth's inquiry about staffing time needed to use this plan, Mr. Kelly explained that the project would be done in-house utilizing the City's work force. It would probably be a 3-person crew with two weeks of work.

Following debate, the motion carried by voice vote. [Note: This item does not need to go before Council. Staff direction was given to move forward.]

8. MOTION DIRECTING CITY CLERK TO PUBLISH NOTICE (NORTH LINCOLN AVENUE INVOLUNTARY ANNEXATIONS)

Reed Berger presented the staff report.

Mr. Otto moved that city clerk be directed to cause a notice to be published in The News-Gazette newspaper advising that annexation of unincorporated territory which is presently wholly surrounded by the
