Senior Planner Rob Kowalski presented staff report on Ordinance No. 2001-08-096: An Amendment to An Annexation Agreement With East Urbana Development Corporation (To Include Provisions for a Revised Preliminary Subdivision Plat Called Beringer Commons – Plan Case No. 1790-S-01) and Ordinance No. 2001-08-087: An Ordinance Approving a Combination Preliminary and Final Subdivision Plat (Beringer Commons Subdivisions – Plan Case No. 1790-S-01).

The East Urbana Development Corporation has submitted a request for a revised preliminary and final subdivision plat, as well as a proposed amendment to the 1991 annexation agreement. The developer is also requesting waivers from the subdivision code related to street width. Staff recommends approval of both ordinances.

Alderwoman Patt moved to approve Ordinance No. 2001-08-087: An Ordinance

Approving a Combination Preliminary and Final Subdivision Plat (Beringer Commons Subdivisions

- Plan Case No. 1790-S-01). The motion was seconded by Alderwoman Wyman and carried 6-0 by roll
