ORDINANCE NO. 2001-12-162

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Vermont Street at Greenridge Drive, Pennsylvania Avenue at Greenridge Drive, and Michigan Avenue at Kinch Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

<u>Street</u>	<u>Direction</u>	<u>Street</u>
Vermont Street Pennsylvania Avenue	Eastbound Eastbound	Greenridge Drive Greenridge Drive
Michigan Avenue	Westbound	Kinch Street

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.



Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
