RE: MFT Resolution for South Lincoln Avenue Improvements

Attached is a Resolution for Improvement by Municipality Under the Illinois Highway Code for the construction of the South Lincoln Avenue Improvements. This resolution is a corrected version of the original resolution that was passed by the City Council on July 19, 1999. The Illinois Department of Transportation recently brought this to our attention thru an informal audit that revealed we had identified this project with the wrong Section number. The Section number used on the first resolution was a Champaign County Section number (95-00002-00-PV). The correct City Section number is 99-00348-00-PV as shown in the Resolution document.

This action of passing a new resolution is recommended by IDOT. The original resolution and project will be closed out showing no money spent on that Section number. The money authorized will then be returned to the City's allotment of MFT funds and reauthorized to the correct Section number. Then the project costs spent to date will be drawn from the proper Section number account. This resolution approval results in no fiscal impacts to the City but is merely an accounting correction to avoid confusion in the District and State offices of IDOT when the final audit is performed.

City staff has reviewed the documents and recommends the approval of the resolution by the City Council.
