There are two attachments to this memo which I hope you will find of use in the upcoming social service funding considerations. The first is a copy of the blank application form that will be available on March 26, 2002. This application is due back to Grants Management Division before 5 pm on April 16, 2002.

The second attachment contains copies of the reports submitted to HUD at the end of each fiscal year. These IDIS (Integrated Disbursement and Information System) report sheets are updated for current available information. I will attempt to explain how this information might be of value to you, but please feel free to give me a call at 384-2447 x428 should you have any questions or concerns.

PGM YEAR: You will see either 2000 (July 1, 2000 - June 30, 2001) or 2001 (July 1, 2001 - June 30, 2002) in this space. This is, of course, the fiscal year determined by the city. Some expenses from FY 2000 were not paid until after July 1, 2001, and as these expenses will be included by HUD in the calculation of total public (social) service monies expended in 2001 fiscal year necessary to calculate the 15% maximum cap on public service expenditures, they are included here. It is common practice to pay expenses for May and June after July 1st as most agencies and organizations do not have this information available until that time. Therefore, staff generally has outstanding reimbursements cross over fiscal years.

PROJECT AND ACTIVITY: These numbers are identification for IDIS purposes - staff uses them to locate the individual programs in the system for reporting purposes.

STATUS: This field identifies if funds are budgeted (meaning the activity is planned but has not yet started), if it is underway and when it has been completed. This field will remain as underway as long as there are outstanding bills yet to be paid, and then completed when all reporting information has been made available to the system.

MATRIX CODE: HUD has provided a list of codes from which staff may choose to best describe what type of activity is being proposed.

REG CITATION: The system provides this information based upon the chosen matrix code.

NATIONAL OBJ: All CDBG activities must benefit one of three designations - low/mod clientele, low/mod households, or a low/mod area (population with more than 50% earning low/mod income).

LOCATION: Besides designating the address of the agency or organization, you will note on the second address line a note as to whether the activity is countywide or citywide. This will tell you whether the activity serves only Urbana residents (citywide) or if it should include other areas (countywide).

DESCRIPTION: A brief description of what activities the funding will cover.

FINANCING: In this area, estimated expenses and funding amounts are entered by staff. The draw amounts are determined by the system and are calculated at the time drawdowns are made from HUD to reimburse the city for checks written to the agencies/organizations to reimburse their eligible expenses. Staff uses the figures to reconcile inhouse accounting systems to the federal system.

ACCOMPLISHMENTS: HUD has provided a listing of codes to be used to identify the persons served by these programs. Generally, in public (social) services, persons served are households, people in general, or youth. Another designation often used is elderly. The system ask for proposed accomplishments when the activity is set up and will not permit the activity to be completed until actual figures are entered.

TOTAL NUMBER OF HOUSEHOLDS ASSISTED: Please note here that Low Mod includes all income levels and is then broken out to Low or Ext Low. Public service activities funded by the city for designated for persons or areas earning less than 50% of the Median Family Income for Champaign County. Staff does not differentiate between Low and Extremely Low in order to make reporting easier for the agencies/organizations receiving funding. In some instances, reports from subrecipients will include this breakdown of financial information available for program participants, and that is included if so. This field also denotes ethnicity of participants as well as all households headed by women.

ACCOMPLISHMENT NARRATIVE: Any information relevant to the activity is entered in this field. HUD has requested as much detail as possible and staff is attempting to comply by the "system cleanup" deadline in June.

I hope this helps you in reading and understanding these reports.
