INTRODUCTION

The attached ordinance and intergovernmental agreement are a result of the Committee of the Whole meetings held on December 10, 2001, and January 28, 2002, which discussed Urbana's share of the subject intersection improvements initiated by the City of Champaign. After the January 28 meeting, staff was directed to negotiate an agreement where Urbana's share would not exceed twenty percent of the construction and engineering costs for the east leg of each intersection. The attached intergovernmental agreement satisfies that directive.

RECOMMENDATION

It is recommended that "AN ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT FOR INTERSECTION IMPROVEMENTS" be approved.

AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF CHAMPAIGN AND THE CITY OF URBANA FOR THE INTERSECTION IMPROVEMENTS AT WRIGHT STREET AND GREEN STREET AND AT WRIGHT STREET AND SPRINGFIELD AVENUE

This agreement entered into this _____ day of May, 2002, between the City of Urbana, in Champaign County, of the State of Illinois, hereinafter called "Urbana", and the City of Champaign, in Champaign County, of the State of Illinois, hereinafter called "Champaign".

WHEREAS, Champaign began its Campustown Infrastructure Reconstruction and

Streetscape Project Phase I on February 18, 2002; and

WHEREAS, Phase I of the project includes reconstruction along Green Street from west of

Fourth Street (in Champaign) to east of Wright Street (in Urbana); and

WHEREAS, Phase 1 of the project also includes improving the Springfield Avenue and

Wright Street intersection (in Champaign and Urbana);

NOW, THEREFORE, Urbana and Champaign agree as follows:

Section 1. Intersection Improvements.

<u>A. Wright Street and Green Street Improvements</u>. In order to facilitate the free flow of traffic and ensure safety to pedestrians and the motoring public, Champaign desires to improve the intersections of Wright Street and Green Street by installing a westbound left turn lane, traffic signals, vehicle detectors, controller, controller cabinet, signal posts, mast arms, combination mast arms with street lighting, left turn lanes with arrows, emergency vehicle preemption, stop line and cross walk markings, and by performing all other work necessary to complete the improvement. The work will be done in accordance with the Campustown Infrastructure Reconstruction and Streetscape Project – Phase 1 plans dated December 31, 2001 designed by Daily & Associates, Engineers, Inc., Clark Dietz, Burtness Engineering Services, and the Hitchcock Design Group.

<u>B. Wright Street and Springfield Avenue Improvements.</u> Champaign is desirous of improving the intersection of Wright Street and Springfield Avenue by installing a westbound left turn lane, traffic signals, vehicle detectors, controller, controller cabinet, signal posts, mast arms, combination mast arms with street lighting, left turn lanes with arrows, emergency vehicle preemption, stop line and cross walk markings, and by performing all other work necessary to complete the improvement. The work will be done in accordance with traffic signal plans as approved June 2002 by the Illinois Department of Transportation designed by Clark Dietz, Inc.

Section 2. Construction Duties.

<u>A.</u> <u>Construction Observation and Inspection.</u> Champaign agrees to perform the surveys, obtain all necessary right of way, prepare plans and specifications, receive bids, award the contract, furnish construction engineering inspection and cause the improvement to be built in accordance with the plans referenced in Section 1.

<u>B.</u> Construction Costs. Champaign agrees to pay for all construction and engineering costs as identified in Section 1, subject to reimbursement by Urbana. Urbana agrees to pay 20% of the total sum of construction and engineering costs east of the east curb line of Wright Street at each intersection in a total amount that shall not exceed \$45,000. Champaign shall invoice Urbana for its share of the project costs and Urbana agrees to pay the cost share for the intersection improvements in one lump sum payable on/or before September 1, 2002.

Section 3. Permission.

For the purposes of the construction referred to in Sections 1 and 2, Urbana hereby gives Champaign permission to work within the right-of-ways identified in Section 1 during the course of the project.

Section 4. Effective Date.

This agreement shall be in effect from the date that the last party signs.

Section 5. Amendments.

Amendments to this Agreement may be made, but only in writing and signed by the parties

hereto.
