#### D. OLD BUSINESS

Following debate, Alderwoman Patt made a motion to approve. Alderwoman Wyman seconded. Debate ensued.

Alderman Otto made a motion to defer this item to the next Council meeting. Alderman Hayes seconded.

Mayor Satterthwaite stated this item would be on the agenda of the next Council meeting.

Alderwoman Patt called a point of order, stating that a majority vote is required to defer since this item is not on the Council agenda for the first time.

Mayor Satterthwaite ruled that since the agenda item was sent to Plan Commission at the last meeting rather than moved and seconded for approval, Council rules allow a deferral by two members.

Alderwoman Patt moved to appeal the ruling of the Chair. Alderwoman Wyman seconded. The Parliamentarian stated the motion to be voted on is "Should the ruling of the Chair be sustained?" A "nay" vote reverses this ruling. Following debate, the vote to sustain the Chair's ruling failed by a show of hands, 2-aye and 4-nay.

- 1. <u>Lincoln Square Lighting</u> -Replaced the series lighting in the areas around Lincoln Square (Race Street, Elm Street and County Plaza area). They should be turned on within the next week or two. Phase I of the Streetscape Project is nearing completion.
- 2. North Cunningham Avenue Finished the asphalt last week on North Route 45. This also aided in making things go smoothly with transporting truckloads of dirt for the O'Brien development project starting this week.

- 3. Comprehensive Plan Focus groups are starting this week.

- 6. <u>Auditors</u> Closing out last year's financial records and should have a report soon.
