Ladies and Gentlemen:

You will have before you at the Urbana City Council meeting on Monday, December 16, a proposal to extend the agreement with the Community Foundation of Champaign County relating to their maintaining the remaining contributed funds relating to Art in the Park.

As you can see from the tent erected in the center of the park, the construction is proceeding. We had hoped to have the center of the park area completed by December 31 and were on track to meet that goal. Unfortunately, we found that some of the marble pieces were cut a little bit too thick. They have to be either cut or replaced. The city arborist and city engineer are in the process of obtaining the replacement marble. Hopefully, then, we will be able to finish the interior of the fountain in the early part of January. All of the marble for the base (excepting those pieces that have to be made thinner) are on site. The fountain is completed and is in Texas awaiting the completion of the marble base.

The fountain and the engineering/plumbing/stone-cutting have been by far the most complicated part of this project. John David Mooney expects to have the large piece ready for installation so that we can dedicate the park in April or May.

I would appreciate your approving the extension agreement with the Foundation until December 31, 2003.
