- RE: Quarterly Investment Report for Quarter Ended Dec. 31, 2002
- DATE: January 22, 2002

The City's investment policy requires that a quarterly investment report be submitted to the City Council. Attached please find the city's investment report as of Dec. 31, 2002.

Two last 2 columns report any changes in investments and cash accounts during the quarter.

Investment activity since last report:

- A \$100,000 CD at Central Illinois Bank matured on 12/6/02. A new CD was purchased at CIB with a 3 year maturity.
- A \$100,000 CD at Union Planter's Bank matured on 12/02/02. A new CD was purchased at Union Planters with a 35 month maturity.
- A \$100,000 CD at Bank Illinois matured on 12/02/02. A new CD was purchased at Bank Illinois with a 3 year maturity.
- 3 CD's at Edward D. Jones (2 at \$85,000 and one at \$86,000) matured on 11/21/02. 3 new CD's at Edward Jones (same value) were purchased, with maturities of 1.5 years, 2 years and 2.5 years.
- Invested \$1 million in the Lord Abbot U.S. Government Securities Fund. Monies can be withdrawn after 30 days notice. Current rate is 4.1%.

Total cash and investments went down approximately \$2.6 million due to normal bill paying and timing of revenues. In the period December through April, the City will normally spend down cash to pay bills.

The City's investment portfolio at Dec. 31, 2002 complies and is in accordance with the City's investment policies that were approved on November 15, 1999.
