RE: Ordinances from Traffic Commission

Attached is an ordinance for your approval from action taken by the Traffic Commission.

The ordinance (Schedule J) is for the prohibition of parking on the south side of Florida Avenue from Smith Road to the east City limits and on the south side of Main Street from just east of Broadway Avenue to Vine Street. The Florida Avenue section is necessary as a continuation of previous restrictions along Florida Avenue. The Savannah Green subdivision has been completed and the roadway is not wide enough to accommodate parking on both sides of Florida Avenue. The Main Street section is required as part of an agreement with the County regarding parking in front of the new courthouse addition. It is desirous of the City and County to prohibit on-street parking in this area and to allow only temporary drop-offs and deliveries in the areas where curbs have been setback. The existing taxi stand just east of Broadway shall remain.

The Traffic Commission has considered and recommends the attached ordinances.

ORDINANCE NO. 2003-02-014

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Florida Avenue; Main Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Street	Between	Side of Street
Florida Avenue	From the centerline of Smith Road to the eastern City limits.	South Side
Main Street	From 140 feet east of the center	South Side

<u>Section 2</u>. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance. Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
