SUBJECT: A RESOLUTION APPROVING THE CITY OF URBANA AND CHAMPAIGN/URBANA/CHAMPAIGN COUNTY HOME CONSORTIUM FY 2003-2004 ANNUAL ACTION PLAN

Description

Included on the agenda of the Urbana City Council Committee of the Whole April 14, 2003 regular meeting is the DRAFT Annual Action Plan (AAP) FY 2003-2004.

In order to receive HUD entitlement funding through the Community Development Block Grant (CDBG) and Home Investment Partnership Act (HOME), the City of Urbana needs to prepare an Annual Action Plan for FY 2003-2004 and submit this plan to U.S. Department of Housing and Urbana Development (HUD) for approval.

The Draft Annual Action Plan includes staff recommendations for the utilization of Community Development Block Grant and Home Investment Partnership Funds for FY 2003-2004.

Issues

The issue is that the Urbana City Council must approve the 2003-2004 Annual Action Plan prior to submitting the AAP to HUD.

The Annual Action Plan process amounts to determining which housing and community development activities are consistent with the Consolidated Plan and should be funded with CDBG and HOME resources for FY 2003-2004.

The schedule for preparing the Annual Action Plan necessitates that the City Council approve the AAP at the April 21, 2003 or the May 5, 2003 Council meeting. This will ensure the document will be submitted to HUD by the May 15, 2003 deadline.

Background

At the January 28, 2003 regular meeting of the Community Development Commission many of the organizations that submitted applications for HOME and CDBG funding gave a brief presentation and answered questions. At this same meeting, the Grants Management Division staff provided a memorandum and briefing that outlined initial staff recommendations for funding the various grant submittals.

At the February 25, 2003 regular meeting of the CDC, staff provided a DRAFT Annual Action Plan, Version 1.0 for review. Staff provided a memorandum and briefing, which included a variety of supplemental information regarding applications submitted for funding.

A 30-day public comment period to review the DRAFT AAP has been completed. The comment period ran from February 18 to March 19, 2003. Copies of minutes and attendance sheet are included in the AAP. Staff did not receive any significant comments during the course of the 30-day public comment period.

At the March 25, 2003 regular meeting of the CDC, staff provided a DRAFT Annual Action Plan Version 1.5, which took into account previous comments and concerns. The most significant changes in this version were that included adjustment to account for HUD changes to total grant amount estimates for CDBG and HOME funding. Specifically, the HUD indicated that the Urbana HOME Consortium would receive an additional \$71,315 and that Urbana's Community Development Block Grant Program would be reduced by \$2,000. The following is summary of the budgetary adjustments associated with the new HUD funding levels:

Community Development Block Grant Program (CDBG)

The 2003-2004 Grant and Available Resources line items have been adjusted to reflect the \$2,000 reduction of CDBG funding.

The Travel line item under Administration was reduced by \$400 and the funding for the Developmental Services Foundation Training and Employment Center was reduced by \$1,600. These adjustments offset the \$2,000 CDBG funding reduction.

Staff also included a number of administration-type adjustments related to citing accurate federal regulations concerning environmental review requirements.

An adjustment was made to the Property Acquisition line item in the CARRYOVER ACTIVITIES section. Staff included maintenance as an activity and deleted reference to the Illinois Center for Citizen Involvement.

HOME Investment Partnership Action (HOME)

The Federal line of the Total Resources and Local Match requirement budget has been adjusted to reflect \$71,315 increase in HOME funding.

Administration was increased by 6,681. Minor increases were made to Other Administrative Expenses (3,100) and the bulk of additional funding was added to the Personnel line item (4,031).

The CHDO 15% Set-Aside funding realized an increase of \$10,698. This additional funding was added to the Homestead Corporation Rental Housing Development line item. Since the Urban League Lease Purchase Program desires to limit per unit HOME investment to \$14,999, no additional funding was included in this line item. The additional funding for Homestead will provide additional funding to purchase rental housing.

The following text was added to the Homestead Corporation Rental Housing Development project description: The Urbana units may serve as replacement units for the Lakeside Terrace Redevelopment Project, under an approved redevelopment plan. Homestead is a partner with Brinshore Development LLC, the firm selected to redevelopment Lakeside Terrace.

The CHDO 5% Set-Aside realized an increase of \$3,565. The additional funding was divided in a pro-rated fashion between the Consortium's CHDOs, Homestead Corporation and Urban League Development Corporation.

The City of Champaign provided staff with the following adjustments to their allocation budget. The Program Delivery line item has been deleted. The Full Home Rehab Program funding has been increased by \$14,321. An Urban League Lease/Purchase Program has been added and funded in the amount of \$50,000.

Champaign County's allocation realized an increase of \$5,241. These funds were pro-rated between the County's Housing Rehabilitation and Program Delivery line items.

The City of Urbana's allocation realized an increase of \$21,529. This additional funding was placed in the New Housing Construction line item.

At the request of Alderwoman Esther Patt, staff is providing a summary outline of progress made by Homestead Corporation's Rental Acquisition and Urban League's Lease-Purchase Program.

Urban League of Champaign County Development Corporation Principal Reduction Lease Purchase Program April 4, 2003

Seven (7) homes have been purchased in Urbana and participants have purchased three (3).

Urban League has provided credit counseling to 376 persons from July 2002 through March 2003.

Homestead rents these units to families utilizing Section 8 Housing Vouchers. As such, these families pay 30% of their income for rent.

Options

Options for Council action include the following:

- 1. Approve the FY 2002-2003 AAP and forward the Resolution to Council for approval.
- 2. Approve the FY 2002-2003 AAP, with changes to be inserted into the document and forward the Resolution to Council for approval.
- 3. Do not approve the FY 2002-2003 AAP and task staff with activities necessary to obtain Council approval.

Fiscal Impacts

Failure to approve the AAP in a timely manner could result in delays with drawing funds from

HUD and delays in implementing projects listed in the AAP. Both the County and City of Champaign would also realize any delay in the availability of funds.

The AAP must be in HUD's Chicago Office by May 17, 2003.

Approval of the AAP and subsequent approval from HUD provides the City of Urbana with the following entitlement dollars: \$577,000 CDBG funds \$402,394 HOME funds *HOME program requires \$71,141 matching funds

WHEREAS, the City of Urbana has been designated an entitlement city under the Federal Housing and Community Development Act of 1974, as amended, and as such is eligible for Community Development Block Grant (hereinafter "CDBG") funds upon proper submittal being made to the United States Department of Housing and Urban Development (hereinafter "HUD"); and

WHEREAS, the City of Urbana has been designated lead entity for the Urbana HOME Consortium in accordance with the Cranston-Gonzales National Affordable Housing Act of 1990, as amended, and as such is eligible to receive HOME Investment Partnerships (hereinafter "HOME") funds on behalf of the City of Urbana, City of Champaign, and Champaign County; and

WHEREAS, on January 5, 1995, HUD published a final rule in the Federal Register requiring a five-year consolidated plan and annual action plans for all HUD community planning and development formula grant programs, consolidating into a single annual submission the planning, application, and reporting aspects of the CDBG, HOME, Emergency Shelter Grants, and Housing Opportunities for Persons with AIDS Programs, and the Comprehensive Housing Affordability Strategy; and

WHEREAS, the Urbana City Council approved the Urbana Home Consortium and the City of Urbana Consolidated Plan for Program Years 2000-2004 on May 8, 2000; and

WHEREAS, the Urbana Home Consortium and the City of Urbana Consolidated Plan for Program Years 2000-2004 was amended on October 2, 2000; and

WHEREAS, the Urbana Community Development Commission, assisted by Urbana Community Development Services staff, has prepared the *City of Urbana* and Champaign/Urbana/Champaign County HOME Consortium FY2002-2003 Annual Action Plan (hereinafter the "Annual Action Plan"); and

WHEREAS, on February 17, 2003, a notice was published in the Champaign-Urbana News Gazette describing the Annual Action Plan; announcing a public review period beginning February 18, 2003, and ending March 19, 2003; and announcing March 10, 2003, public hearings on the Annual Action Plan; and

WHEREAS, Community Development Services staff held a public hearing on the Annual Action Plan on March 10, 2003, at the Urbana City Building, 400 South Vine Street, Urbana, Illinois; and

WHEREAS, at its March 25, 2002 meeting, the Urbana Community Development Commission recommended adoption of the Annual Action Plan by the Urbana City Council; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the City of Urbana and Champaign/Urbana/Champaign County HOME Consortium FY 2003-2004 Annual Action Plan, as attached hereto and incorporated herein by reference, is hereby approved.

Section 2. That the Mayor is hereby designated as the authorized representative of the City of Urbana to take any action necessary in connection with said Annual Action Plan to implement the CDBG and HOME programs and to provide such additional information as may be required.

Section 3. That upon review and comment by the Urbana Community Development Commission, the Mayor is hereby designated to execute subgrantee agreements for the following programs and activities identified in said Annual Action Plan.

INTRODUCTION

The Urbana HOME Consortium and the City of Urbana Annual Action Plan for FY 2003-2004 identifies activities to be implemented by the City of Urbana and members of the Urbana HOME Consortium during the period beginning July 1, 2003, and ending June 30, 2004. The Annual Action Plan budgets the use of two federal housing entitlement funds: Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME). The CDBG portion of the Annual Action Plan identifies uses of CDBG entitlement funds by the City of Urbana. The HOME portion of the plan identifies uses of HOME funds by members of the Urbana HOME Consortium (a.k.a. the Champaign/Urbana/Champaign County HOME Consortium).

The Annual Action Plan for FY 2003-2004 has been developed to further five-year strategies identified in the *Urbana HOME Consortium and City of Urbana Consolidated Plan for Program Years 2000-2004.* The Annual Action Plan identifies activities to be undertaken during the fourth year of the Consolidated Plan five-year planning period.

The Annual Action Plan has been on file for public review and comment during a period beginning February 3, 2003 and ending March 7, 2003.

On March 10, 2003 the City of Urbana held public hearings to obtain comments regarding a draft Annual Action Plan. The hearings were held at 10:00 a.m. and 6:00 p.m. in the Council Chambers of the Urbana City Complex, 400 South Vine Street. All comments received at the hearing, as well as other written comments submitted during the public review period, are included in the Annual Action Plan.

Emergency Grant, Access Grant, and Get the Lead Out Match Programs (FY 03-04)

Funds will be contributed toward three programs:

- 1. Providing repairs necessary to alleviate hazardous conditions, which pose a threat to the health and safety of a homeowner. Homeowners earning less that 50% of the Median Family Income for Champaign County are eligible for the Emergency Grant Program.
- 2. General improvements necessary to remove barriers to accessibility by persons with disabilities. The Access Grant Program is available for homeowners or renters who earn less than 80% of Median Family Income.
- 3. Matching funds for the Illinois Department of Public Health Get the Lead Out Program, which will fund efforts to address lead based paint hazards in four (4) housing units.

All programs are available citywide. All work activities will be accomplished through contract arrangements.

In reviewing applications for funding under the Consolidated Social Services Program, specifically those eligible for CDBG monies, consideration will be given to those activities which offer maximum benefit to very low- and low-income Urbana households.

Specific Objective Number I-2

Not less than seventy percent (70%) of the aggregate of CDBG fund expenditures shall be for activities benefiting low- and moderate-income persons as established annually by HUD.

Specific Objective Number I-3

One Hundred percent (100%) of HOME funds will be used to assist families with incomes below eighty percent (80%) of the area median family income as established annually by HUD.

Priority Need Category

Community Development-Public Facilities

Specific Objective Number J-1

Certain block groups within Census Tracts 53, 54, and 55 are designated as the City's Community Development Target Area. In considering activities to be funded under CDBG, emphasis will be placed on activities that benefit persons in these neighborhoods.

Specific Objective Number J-2

Funds will be contributed to the development and construction of a new facility for emergency childcare (Crisis Nursery).

Priority Need Category

Community Development-Infrastructure

Specific Objective Number K-1

CDBG funds will be contributed for street improvements in CT 54 to Division Avenue, and to Oakland Avenue.

Specific Objective Number K-2

CDBG funds will be contributed to replace series streetlighting in CT 55 with new service.

Specific Objective Number K-3

CDBG funds will be contributed to street improvements associated with Sunset Drive, Coler Avenue, and Lincoln Avenue in CT 53.

Priority Need Category

Community Development-Seniors

Specific Objective Number L-1

Provide minor home maintenance repair service to at least 30 elderly households per program year for the duration of the Consolidated Plan.

Specific Objective Number L-2

Provide free collection of junk and debris, as well as appliance pick-up, for elderly homeowners and renters residing in the CD Target Area during Neighborhood Cleanups.

Specific Objective Number L-3

Suggest other supportive services available in the community to elderly homeowners with whom City Staff interact.

Priority Need Category

Community Development-Youth

Specific Objective Number M-1

CDBG Public Service funds will be used to support programs that further the development of positive attitudes and attributes in area youth especially those residing within the CD Target Area.

Specific Objective Number M-2

CDBG Public Service funds will be used to support recreational, educational, and cultural opportunities for youth residing in low- and/or very low-income households.

Priority Need Category

Community Development-Public Services

Specific Objective Number 0-1

In reviewing applications for funding under the Consolidated Social Services Program, specifically those eligible for CDBG monies, consideration will be given to those activities which offer maximum benefit to very low- and low-income Urbana households.

Specific Objective Number 0-2

Certain block groups within Census Tracts 53, 54, and 55 are designated as the City's Community Development Target Area. In considering activities to be funded under CDBG Public Services, emphasis will be placed on activities that benefit persons in those neighborhoods.

Priority Need Category

Community Development-Economic Development/Opportunity Strategy Specific Objective Number P-1

CDBG Public Service funding will be provided to the Urban League of Champaign County for job-training services to be provided to adults recently released from the prison system (EaTAC).

Specific Objective Number P-2

CDBG Public Service funding will be provided to the Urban League of Champaign County for job-training services to be provided to youth as part of its Summer Youth Program.

Specific Objective Number P-3

The City will use CDBG monies to partner with other non-profit agencies to encourage the development of job-training programs addressing work ethics and other skills to enhance job retention among disadvantaged residents.

Priority Need Category

Community Development-Planning and Administration Specific Objective Number Q-1

Using CDBG monies, fund a Neighborhood Organization Grant program to encourage the creation and development of local groups concerned with furthering the interests of the neighborhood. The primary purpose of this program would be to assist such groups to accomplish non-profit status by obtaining a 501(c)3 designation, thereby making them eligible for additional funding.

Specific Objective Number Q-2

The City will serve as service planner, funder, program monitor, and evaluator. City functions shall include promotion of collaborative efforts, using City funds to leverage non-City funds for housing and community development, grant procurement and grant management, and program planning. Service provision will primarily be done by subgrantee agencies including private non-profit organizations.

Specific Objective Number Q-3

The majority of CDBG funds directly benefiting households will be targeted toward households with income at or below 50 percent of median income even though Federal law allows benefit to households earning up to 80 percent of median family income. This guideline shall apply to all programs administered directly by the City as well as those administered by Subgrantees.

Specific Objective Number Q-4

Using HOME funds the City will support the creation of new and the continuation of existing Community Housing Development Organization (CHDOs). The City shall designate no single CHDO; rather multiple organizations with unique program niches shall be encouraged.
