Investment activity since last report:

• A \$197,000 U.S. Government Bond was called early. Proceeds were invested in the Lord Abbott U.S. Government Mutual Fund. Current rate is 3.9%.

Total cash and investments are the same approximate amount as of the end of the last quarter.

The City's investment portfolio at March 31, 2003 complies and is in accordance with the City's investment policies that were approved on November 15, 1999.
