There have been some changes to the development agreement since it was last discussed. Mr. Walden also noted a couple of articles he found concerning special service area financing.

Mayor Satterthwaite addressed the detour around Vine and Washington Streets as a result of road construction being done in that area. He asked that Mr. Gray update the Council on where new signage had been placed, as a result of a couple of accidents that had taken place over the weekend. Mr. Gray reported that temporary 4-way stop signs had been placed at Anderson and Oregon Streets, and at Anderson and California Streets in response to the accidents that occurred. Mayor Satterthwaite appealed to residents to be very cautious when driving in the area, and observe the stop signs.
