RE: Ordinances from Traffic Commission

Attached is an ordinance for your approval from action taken by the Traffic Commission.

The ordinance is for the creation of a no parking restriction and the painting of yellow curb on the south side of Main Street, west of Cottage Grove Avenue. This action is needed to create a separate right-turn lane and through lane for eastbound Main Street traffic.

The Traffic Commission has considered this location at its February, 2001 meeting and recommends that the no parking restriction be approved.

ORDINANCE NO. 2003-07-069

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Main Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At all Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

Street	Between Street	<u>& Street</u>	Side of <u>Street</u>
Main Street	Cottage Grove Avenue	to 176' west of Cottage Grove Avenue	South

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance Shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
