RE: Ordinance from Traffic Commission
No Parking Any Time—400 Block of East Washington Street

Attached is an ordinance for your approval from action taken by the Traffic Commission.

The ordinance (Schedule J) is for the prohibition of parking at all times on the south side of Washington Street from the centerline of Urbana Avenue to 115 feet east of the centerline of Urbana Avenue. This action is necessary to provide more transition taper length from the end of the 3-lane section of the recently completed Washington Street and Vine Street intersection. The ordinance will ensure no vehicles park along this stretch and improve the merging of vehicles from the 3-lane section to the 2-lane section east of Urbana Avenue. This will remove approximately 4 on street parking spaces from the street but adequate spaces remain in the remainder of the block on Washington Street. The residents and owners in the 400 block of East Washington Street have been notified and concur with this action.

The Traffic Commission has considered these locations at its August 2003 meeting and recommends that the ordinance be passed by the City Council.

ORDINANCE NO. 2003-09-094

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Washington Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At all Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between Street</u>	<u>& Street</u>	<u>Side of Street</u>
Washington Street	centerline of Urbana Avenue	to 115' east of Urbana Avenue	South

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance Shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
