RE: Campus Area Transportation Study [CATS], Phase II Addendum

INTRODUCTION

In the fall of 2001, the CATS Phase II Technical Committee decided to suspend further study and preliminary engineering for this project because of the Champaign-Urbana Mass Transit District [C-U MTD] Alternatives Analysis Study. For the last 2½ years, the C-U MTD Alternatives Analysis Study has been undertaken and, at this juncture, there is no firm determination that would show exactly where a light rail or flexible transit route would be designated. Rather than continuing to stall the CATS Phase II work, the Technical Committee decided to resume efforts and have Clark Dietz, Inc., finish over the next twelve months the remaining work.

The proposed addendum is an amount not to exceed \$112,600. This fee includes \$98,700, payable to Clark Dietz, Inc., \$8,000 to Champaign County Regional Planning Commission for administrative costs, and the balance for updated aerial photography. Of the \$112,600 expenses, \$60,000 are to be borne equally by the City of Champaign, the Champaign-Urbana Mass Transit District, and the University of Illinois for fees already incurred in 2001 (\$52,600) while analyzing various street circulations and configurations, and alternative bus routes in Champaign.

The remaining work (\$52,600) to be completed includes: 1) determining pedestrian traffic signal locations on campus; 2) reviewing bicycle issues and developing schemes for conflict mitigation; 3) develop basic geometry for Green Street, between Wright Street and Lincoln Avenue; 4) develop basic design, including methods of increasing capacity along Springfield Avenue, between Neil Street and Wright Street; 5) develop design improvements for Fourth Street, between Green Street and Gregory Drive and on Goodwin Avenue, between Gregory Drive and Springfield Avenue; 6) address signal improvements and coordination, and transit issues on First Street, between Green Street and Kirby Avenue; 7) address bikepath, parking, and transit issues on Mathews Avenue, between Nevada Street and Springfield Avenue; 8) perform analysis of capacity,

pedestrian accommodations, and transit issues under a three-lane section on Lincoln Avenue, between Vermont Avenue and Oregon Street; 9) incorporate the proposed alignment of MTD's fixed guideway system; 10) prepare a final report. This work is expected to be completed by March 31, 2005. The City of Urbana, the City of Champaign, the University of Illinois, and the Champaign-Urbana Mass Transit District will equally pay \$13,150 each.

AN ADDENDUM TO AN INTERGOVERNMENTAL AGREEMENT FOR THE CAMPUS AREA TRANSPORTATION STUDY, PHASE 2, BETWEEN

THE CITY OF CHAMPAIGN, THE BOARD OF TRUSTEES OF THE UNIVERSITY OF ILLINOIS, THE CHAMPAIGN-URBANA MASS TRANSIT DISTRICT AND THE CITY OF URBANA

This Addendum, made and entered into on the last date written below, by and between the City of Champaign, Illinois, a municipal corporation ("Champaign"); the City of Urbana, Illinois, a municipal corporation ("Urbana"); the Board of Trustees of the University of Illinois, a body corporate and politic of the State of Illinois ("University"); and the Champaign-Urbana Mass Transit District, a municipal corporation ("MTD").

WITNESSETH:

Whereas, Section 10 of Article VII of the Constitution of the State of Illinois, 1970, provides authority for local governments to contract or otherwise associate among themselves to obtain and share services and to exercise, combine or transfer any power of function in any manner not prohibited by law or ordinance; and

Whereas, the Intergovernmental Cooperation Act (5 ILCS 220/1-220/9) also provides that any one or more public agencies may contract with any one or more other public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the contract is authorized by law to perform provided that such contract shall be authorized by the governing body of each party to the contract; and

Whereas, Champaign, Urbana, the University, and MTD entered into a Campus Area Transportation Study Intergovernmental agreement in 1997 to provide for a study of the transportation issues in the Campus Area; and

Whereas, the Campus Area Transportation Study (CATS) was completed in 1999 as a result of that Intergovernmental Agreement; and

Whereas, Champaign, Urbana, the University, and MTD entered into an Intergovernmental Agreement for the Campus Area Transportation Study, Phase 2 (CATS, Phase 2) on December 15, 2000 for the conceptual design of the recommendations of CATS; and

Whereas, Champaign, Urbana, the University and MTD on January 2, 2002, approved a Letter of Understanding defining the terms of suspension of work on CATS, Phase 2, and establishes the intention of the parties to amend the intergovernmental agreement in the future at such time as it is prudent to reinitiate work on CATS, Phase 2 and negotiate a new scope of service that reflect the recommendations of the Fixed-Guideway Study; and

Whereas, Champaign, Urbana, the University and MTD have determined it to be in their mutual interest to resume work on CATS Phase 2,

Now, therefore, in consideration of the mutual promises and covenants contained herein, Champaign, Urbana, MTD and the University hereby agree as follows:

Section 1. Revised Scope of Work for Transportation Consultant. The parties agree that the consultant's scope of work shall include additional transportation evaluation of the following items:

- 1) Determine pedestrian signal locations.
- 2) Review bicycle issues and develop schemes for conflict mitigation.
- 3) Develop basic geometrics, including Level of Service Analysis for Green Street between Wright Street and Lincoln Avenue.
- Develop basic design, including methods of increasing capacity along Springfield Avenue between Neil Street and Wright Street.

- 5) Develop design improvements for:
 - a. Fourth Street from Green Street to Gregory Drive
 - b. Goodwin Avenue from Gregory Drive to Springfield Avenue
- 6) Address signal improvements and coordination and transit issues on First Street from Green Street to Kirby Avenue.
- 7) Address bike path, parking and transit issues on Mathews Avenue from Nevada Street to Springfield Avenue.
- 8) Perform analysis of capacity, pedestrian accommodations and transit issues under a three-lane section of Lincoln Avenue between Vermont Avenue and Oregon Street.
- 9) Incorporate the proposed alignment of MTD's fixed-guideway system.
- 10) Preparation of a final report.

<u>Section 2. Revised Completion Date.</u> The parties agree that the consultant's final report of the Campus Area Transportation Study, Phase 2, shall be completed by March 31, 2005.

Section 3. Contracting Agency. The parties agree that the Champaign County Regional Planning Commission shall continue to act as the contracting agent for the parties for the purpose of entering to a change order to the consulting agreement with Clark-Dietz, Incorporated.

Section 4. Payment. The parties agree that the total fees for the additional scope of work shall not exceed \$112,600 bringing the total project cost to \$338,300. The additional cost is to be divided among the parties as follows:

Champaign - \$33,150

University - \$33,150

MTD - \$33,150

Urbana - \$13.150

<u>Section 5. Terms.</u> This amendment to the agreement shall be effective as of the date of its execution by the last of the parties to approve it and shall remain, and continue in full force and effect for two (2) years, or until the successful completion of the scope of work included in this amendment, whichever is shorter.
