**RE:** Ordinance from Traffic Commission

Attached is an ordinance for Council approval from action taken by the Traffic Commission.

The attached ordinance (Schedule H) is for the placement of stop signs at several locations. The locations are in the Beringer Commons, Southridge V and Lincolnwood II subdivisions. These stop signs are required due to the new street construction in these subdivisions. The new streets and resulting new home construction in this area have increased the amount of traffic on the collector streets of Beringer Circle and Michigan Avenue and on the arterial street of Philo Road; therefore, these stop signs are needed and warranted under Section 2B-5 of the Manual on Uniform Traffic Control Devices. More specifically, these warrants state that a stop sign may be warranted if one or more of the following conditions exist:

- 1. Intersection of a less important road with a main road where application of the normal right-of-way rule is unduly hazardous.
- 2. Street entering a through highway or street.
- 3. Unsignalized intersection in a signalized area.
- 4. Other intersections where a combination of high speed, restricted view, and serious accident record indicates a need for control by the STOP sign.

The conditions are met for numbers 1 and 2 above are met for Artesia Crossing at Beringer Circle, Rutherford Drive at Beringer Circle, Marc Trail at Philo Road and Greenridge Drive at Michigan Avenue.

The Traffic Commission considered these locations at its August 2002 and April 2004 meetings and recommends that the stop signs be installed.

# AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Artesia Crossing at Beringer Circle, Rutherford Drive at Beringer Circle; Marc Trail at Philo Road; Greenridge Drive at Michigan Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersections:

Street	Direction	Street
Artesia Crossing	Eastbound	Beringer Circle
Artesia Crossing	Westbound	Beringer Circle
Rutherford Drive	Westbound	Beringer Circle
Marc Trail	Westbound	Philo Road
Greenridge Drive	Northbound	Michigan Avenue
Greenridge Drive	Southbound	Michigan Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.






