## URBANA CITY COUNCIL MEETING MAY 17, 2004

The City Council of the City of Urbana, Illinois, met in regular session Monday, May 17, 2004 in the Council Chambers at the Urbana City Building.

There being a quorum, Mayor Satterthwaite called the meeting of the Urbana City Council to order at 7:30 p.m.

#### A. APPROVAL OF MINUTES OF PREVIOUS MEETING

May 3, 2004 - Alderwoman Wyman made a motion to approve the minutes of the meeting held May 3, 2004. Alderman Hayes seconded.

Alderwoman Patt noted a correction on page 1 under "Minutes of Previous Meeting." It should be corrected to show Alderwoman Wyman as seconding the motion. Thus, reading: "The motion was seconded by Alderwoman Wyman and carried by a voice vote." There were no objections.

Alderwoman Wyman seconded. The motion carried by a voice vote.

#### C. PETITIONS AND COMMUNICATIONS

Zachary C. Miller, 107 W. Washington, addressed the Council in support of the ward map and the veto override. He also expressed his support for the Greenways and Trails Program.

Andre Arrington, representing Don Moyer Boys & Girls Club, addressed the Council with appreciation for their support and presented Council Members with a gift made by the children.

Brett Stillwell, 201 W. Springfield, representing Campus Town Development, did not speak but would be available to answer questions concerning the proposed rezoning for portions of 502, 504, 506 and 602 S. Glover.

David Monk addressed the Council with expressions of gratitude for allowing the public the right of discussion before or when an agenda item is presented.

Alderwoman Patt informed the Council that Alderwoman Wyman graduated from the College of Law this passed weekend. The Council applauded Alderwoman Wyman on her success.

#### f. Ordinance No. 2004-03-026: An Ordinance Amending the Code of Ordinances Regarding Maximum Fines and Pay-By-Mail Minimum Fines

Alderwoman Wyman made a motion to approve. Alderwoman Patt seconded.

Alderwoman Chynoweth moved to amend the proposal with changes that would include a \$50.00 minimum pay-by-mail fine for: (Chapter 15) Disorderly conduct, Curfew for minors, and Hindering performance by or refusing to obey direction of city officer or employee; and (Chapter 20) Permission required for sidewalk obstructions. Alderwoman Patt seconded. Debate ensued.

Alderman Whelan requested a roll call vote on the motion to amend. The vote was as follows:

The motion carried by roll call vote (6-aye:1-nay).

"WHEREAS, those fines are substantially lower than the minimum fines established by the Urbana's adjacent neighbor, the City of Champaign, for its pay-by-mail system, as shown in the following..."; and

"WHEREAS, the City of Champaign has raised its maximum fines to \$750."

Alderwoman Patt seconded. The motion carried by a voice vote.

The vote on the main motion to approve was as follows:

# 2. Mayoral Appointment - Community Development Commission (Theresa Michelson)
