AN ORDINANCE TEMPORARILY AUTHORIZING PARKING ON A STREET LISTED ON SCHEDULE JOF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Florida Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following street is listed on Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code; however, because of circumstances of that road not presently being a through road and consequently has low traffic volumes that parking shall be temporarily permitted, except as listed below, on that road until two years hence or until made a through street whichever comes sooner:

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
